RESOLUTION NO. 756-98

[Office of Juvenile Justice and Delinquency Prevention]

1 AUTHORIZING THE MAYOR'S CRIMINAL JUSTICE COUNCIL TO ACCEPT AND EXPEND
2 FUNDS IN THE AMOUNT OF \$274,409 FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF
3 JUVENILE JUSTICE AND DELINQUENCY PREVENTION (OJJDP), TO SUPPORT THE
4 IMPLEMENTATION OF THE COMPREHENSIVE EFFORT TO REFORM THE JUVENILE JUSTICE
5 SYSTEM OF THE CITY AND COUNTY OF SAN FRANCISCO.


6 WHEREAS, OJJDP is the agency within the U.S. Department of Justice which provides grants to local
7 and state governments across the nation to support innovative programs for juvenile justice and
8 delinquency prevention; and,


9 WHEREAS, on July 21, 1998 the U.S. Department of Justice OJP awarded the Mayor's Criminal
10 Justice Council of the City and County of San Francisco \$274,409 for fiscal year 1998-99 to support
11 program activities of the Mayor's Juvenile Justice Action Plan; and,


12 WHEREAS, the project period of this grant award is from July 1, 1998 to June 30, 2001, and funds will
13 be renewable each fiscal year contingent on federal appropriations; and,

14 WHEREAS, the entire award by OJJDP of the U.S. Department of Justice funds direct services, it is
15 requested that indirect costs be waived; now, therefore, be it

16 RESOLVED, That the City and County of San Francisco hereby authorizes the Director of the Mayor's
17 Criminal Justice Council to accept and expend \$274,409 from the U.S. Department of Justice, Office of
18 Juvenile Justice and Delinquency Prevention in support of the Mayor's Juvenile Justice Action Plan.
