5 VIOLENCE CAN BE PRACTICALLY PERFORMED FOR THE DISTRICT ATTORNEY'S
6 VICTIM WITNESS ASSISTANCE PROGRAM BY A PRIVATE CONTRACT FOR A LOWER
7 COST THAN SIMILAR WORK SERVICES PERFORMED BY CITY AND COUNTY
8 EMPLOYEES

9 IT IS FURTHER RESOLVED, that the Community United Against
10 Violence has established and will maintain networks of persons to
11 safeguard neighborhoods, conduct workshops on personal safety, self-
12 defense and property protection including, but not limited to,
13 providing a domestic violence housing specialist to handle the
14 transitional housing to assist victims to obtain new permanent
15 households and, under the direction of the Victim Witness Assistance
16 Program, helps victims and witnesses to cooperate with the criminal
17 justice system in prosecution of the guilty and alleviation of their
18 own injuries, and

19 WHEREAS, the electorate of the City and County of San Francisco
20 passed Proposition J in November 1976 adding Section 8.300-1 to the
21 Charter allowing City Departments to contract with private companies
22 for specific services, which can be practically performed for a lower
23 cost than similar work by City and County employees, and

24 WHEREAS, the Office of the District Attorney has sought and
25 received estimates from private contractors and wishes to contract
for these services, and the Controller has certified on December 21, 2000




