2 COMMENDING TREASURER SUSAN LEAL, THE SAN FRANCISCO FEDERAL CREDIT  
3 UNION, AND OTHER PROJECT PARTNERS ON THE INSTALLATION OF THE NATION'S  
4 FIRST AUDIO ENHANCED ATM IN SAN FRANCISCO CITY HALL

5 WHEREAS, On Friday, October 1<sup>st</sup>, 1999 San Francisco Treasurer Susan Leal  
6 unveiled the nation's first audio enhanced Automated Teller Machine ("ATM") here in City  
7 Hall; and,

8 WHEREAS, This "talking" ATM allows people who are blind or partially sighted to use  
9 the machine without assistance; and,

10 WHEREAS, The San Francisco Federal Credit Union, which offered this talking ATM at  
11 no extra cost to the City operates the ATM for use by all City Hall customers, with no  
12 surcharges; and,

13 WHEREAS, The Credit Union teamed with T-Base Communications, Inc., to create the  
14 talking ATM, as well as Diebold, Inc., Deluxe Corporation, and the CO-OP Network; and,

15 WHEREAS, Members of the disability community, including representatives from the  
16 Mayor's Disability Council and the Mayor's Office on Disability, were continually involved in  
17 the planning and installation process; now, therefore, be it

18 RESOLVED, That the San Francisco Board of Supervisors hereby recognizes the  
19 pioneering efforts of City Treasurer Susan Leal, the San Francisco Federal Credit Union, and  
20 other partners on the occasion of the installation of the nation's first talking ATM.


