3 **Resolution supporting the programming of \$7,300,000 of funding from the Octavia**  
4 **Boulevard Special Fund for Proposition I Ancillary Projects.**

6 WHEREAS, In 1999, the voters of San Francisco approved Proposition I, which  
7 required the City to use certain Central Freeway parcel sales and dispositions proceeds for  
8 transportation improvements to corridors on or ancillary to Octavia Boulevard (Ancillary  
9 Projects), with the San Francisco County Transportation Authority (Authority) to allocate  
10 such proceeds for the Ancillary Projects; and

11 WHEREAS, Under Ordinance No. 271-03, adopted by the Board of Supervisors on  
12 November 25, 2003, a copy of which is on file with the Clerk of the Board of Supervisors in  
13 File No. 031657 and is incorporated herein by reference, the Board of Supervisors  
14 authorized the creation of the Octavia Boulevard Special Fund, which is to be used for  
15 selected Ancillary Projects; and

16 WHEREAS, After initially selecting Ancillary Projects in 2006, the SFCTA has revised  
17 the selected Ancillary Projects to include ten proposed Ancillary Projects adopted by the  
18 SFCTA Board of Commissioners (Additional Ancillary Projects); and

19 WHEREAS, The Additional Ancillary Projects will not be implemented until after  
20 environmental review has been completed; now therefore be it

21 RESOLVED, That the Board of Supervisors supports the programming of up to  
22 \$7,300,000 in funding from the Octavia Boulevard Special Fund for the Additional Ancillary  
23 Projects.
