3 **Ordinance authorizing settlement of the lawsuit filed by N.C., a minor against the City**  
4 **and County of San Francisco for \$45,000; the lawsuit was filed on July 17, 2017, in**  
5 **United States District Court, Case No. 17-cv-4016; entitled N.C., a minor v. City and**  
6 **County of San Francisco, et al.; the lawsuit involves allegations of civil rights**  
7 **violations.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled N.C., a minor v. City and County of  
12 San Francisco, et al., United States District Court, Case No. 17-cv-4016 by the payment of  
13 \$45,000. The lawsuit involves allegations of civil rights violations.

14 Section 2. The above-named action was filed in United States District Court for the  
15 Northern District of California on July 17, 2017 and the following parties were named in the  
16 lawsuit: Plaintiff: N.C.; Defendants City and County of San Francisco, Former Acting Chief  
17 Toney Chaplin, Maris Goldsborough, Gabriel Alcaraz, Ali Misaghi, Eduard Ochoa, Carlos  
18 Mustafich and David Johnson.


