7 Be it ordained by the People of the City and County of San Francisco:

8 I. The Board of Supervisors hereby implements the provisions of the  
9 Memorandum of Understanding (MOU) between the Superior Court of California, County of  
10 San Francisco and the International Federation Of Professional And Technical Engineers,  
11 Local 21 (IFPTE, Local 21 or Local 21). The provisions so implemented are on file in the  
12 office of the Board of Supervisors.

13 II. The General Fund of the City and County of San Francisco shall not be used to  
14 fund any of the salary increases or benefits referred to in the MOU. The City shall not be  
15 liable for any costs incurred in providing the wages and other benefits set forth in the MOU.  
16 The City's obligation under this ordinance shall be limited to administering health and  
17 retirement benefits and payroll processing. This paragraph shall not apply to the payment of  
18 wages and benefits for those positions covered by this ordinance which are specifically  
19 authorized and funded by the City budget.

20 III. The City's obligations described herein are not intended to create a dual  
21 employer relationship.

3 consistent with, and authorized by this ordinance that were taken before its effective date.




