3 **Ordinance authorizing settlement of the lawsuit filed by Kirstin Johnson, et al. against**
4 **the City and County of San Francisco for \$75,000; the lawsuit was filed on October 25,**
5 **2019, in San Francisco Superior Court, Case No. CGC-19-580277; entitled Kirstin**
6 **Johnson, et al. v. Kierstie Barr, et al; removed to United States District Court, Case No.**
7 **20-cv-01569-SK; the lawsuit involves alleged civil rights violations.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kirstin Johnson, et al v. Kierstie Barr,
12 et al., United States District Court, Case No. 20-cv-01569-SK by the payment of \$75,000.
13 The lawsuit involves alleged civil rights violations.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 October 25, 2019 and subsequently removed to United States District Court, and the following
16 parties were named in the lawsuit: Plaintiffs: Kirstin Johnson, minor children F.M., M.D.M.,
17 M.P.M., V.M., and T.M; Defendants: City and County of San Francisco, SFPD Officer Kierstie
18 Barr, SFPD Officer Samson Hung, SFPD Lieutenant Marina Chacon, SFPD Sergeant Flint
