1 IDENTIFYING THE CENSUS TRACTS COMPRISING THE "TARGETED
2 EMPLOYMENT AREA" (TEA) FOR THE SAN FRANCISCO ENTERPRISE ZONE.

4 WHEREAS, On March 20, 1984, the Governor of the State of California signed into law
5 Assembly Bill 40 (Government Code Section 7070 et seq.) the "Enterprise Zone Act," creating a
6 State Enterprise Zone Program; and,

7 WHEREAS, On May 28, 1992, the State Department of Commerce designated the San
8 Francisco Enterprise Zone pursuant to the Enterprise Zone Act; and,

9 WHEREAS, On September 26, 1996, the Governor of the State of California signed into
10 law Senate Bill 2023 and Assembly Bill 296, effective January 1, 1997, revising the Enterprise
11 Zone Act and requiring, among other things, that Enterprise Zones establish "Targeted
12 Employment Areas" to encourage businesses within an Enterprise Zone to hire eligible residents
13 from geographic areas of the city in most need of employment targeting; now, therefore, be it

15 RESOLVED, That each of the following census tracts, which have all been designated by
16 the United States Department of Housing and Urban Development as having 51 percent of their
17 residents at low- or moderate-income levels, is hereby identified as among those census tracts
18 which are in most need of employment opportunities pursuant to the Enterprise Zone Act, as
19 amended: 101, 106, 107, 110, 111, 113, 114, 115, 117, 118, 119, 120, 121, 122, 123, 124, 125,
20 155, 158, 161, 162.98, 163, 164, 165, 166, 167, 168.98, 169, 176.98, 177, 178, 179.02, 180,
21 201.98, 202.98, 203, 208, 209, 210, 226, 228, 229, 231, 232, 233, 234, 605; and, be it

22 FURTHER RESOLVED, That a targeted employment area composed of the above
23 specified census tracts is hereby approved by the San Francisco Board of Supervisors; and, be it

24 FURTHER RESOLVED, That a copy of this resolution be forwarded to the State
25 Department of Trade and Commerce for final approval.




