DECLARING THAT IT IS THE POLICY OF THE CITY AND COUNTY OF SAN FRANCISCO NOT TO SEEK OR OTHERWISE USE ANY OF THE PERSONAL INFORMATION PROVIDED IN THE CENSUS QUESTIONNAIRE TO ENFORCE LAWS INCLUDING BUT NOT LIMITED TO HOUSING AND BUILDING CODES, ELIGIBILITY FOR WELFARE, SOCIAL AND HEALTH SERVICES PROGRAMS AND FURTHER URGING THE UNITED STATES BUREAU OF THE CENSUS, THE MAYOR, ALL CITY DEPARTMENTS AND COMMUNITY BASED ORGANIZATIONS TO PUBLICIZE THAT THE INDIVIDUAL RESPONSES TO THE CENSUS QUESTIONNAIRE ARE STRICTLY CONFIDENTIAL AND FURTHER URGING CITY DEPARTMENTS AND COMMUNITY BASED ORGANIZATIONS TO PROMOTE AND MAKE AVAILABLE "BE COUNTED FORMS" TO CITY RESIDENTS

WHEREAS, The decennial census conducted by the U.S. Bureau of Census ("Bureau") is mandated by the U.S. Constitution for the purpose of political reapportionment; and

WHO DO NOT HAVE MAILING ADDRESSES, LIVE IN CROWDED OR MULTIPLE FAMILY

WHEREAS, The U.S. Congress has enacted federal laws and programs that rely on an accurate population count and socioeconomic information to allocate federal funds for numerous education, transportation, social service, and other programs; and

WHEREAS, The City and County of San Francisco relies on census data for planning decisions and allocating government funds; and

WHEREAS, The 1990 Census failed to count over 837,000 people in California, resulting in the loss of at least one Congressional seat and over a hundred million dollars in federal funding; and

WHEREAS, The 1990 Census missed almost 22,000 San Francisco residents, about

WHEREAS, The undercount in the 1990 Census resulted in San Francisco receiving significantly less federal funding for a wide range of programs that benefit San Francisco residents; and

WHEREAS, The number of San Francisco children missed in the 1990 Census would fill nine additional public schools; and

WHEREAS, San Francisco has large populations that have been historically undercounted by the Bureau; and

WHEREAS, Experience from other jurisdictions has demonstrated that reducing the undercount requires a coordinated effort by local government agencies, community-based organizations, and the Bureau of Census; and

WHEREAS, Many San Franciscans, especially belonging to traditionally marginalized groups, are fearful of confidentiality being compromised because of immigration status, dwelling within illegal in-law housing units or not having proper work permits and therefore, do not complete the Census questionnaire; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby declares that it is the policy of the City and County of San Francisco not to seek or otherwise use any of the personal information provided in the Census questionnaire to enforce laws including but not limited to housing and building codes, eligibility for welfare, social and health services programs; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby urges the United States Bureau of the Census, the Mayor, all City Departments and community based organizations to publicize that the individual responses to the Census questionnaire are strictly confidential; and be it
