4 **Resolution retroactively authorizing the Department of Public Health to accept and**
5 **expend a grant increase of \$295,205 for a total amount of \$783,091 from Centers for**
6 **Disease Control and Prevention to participate in a program entitled National HIV**
7 **Behavioral Surveillance-San Francisco for the period of January 1, 2017, through**
8 **December 31, 2017.**

10 WHEREAS, Centers for Disease Control and Prevention has agreed to fund
11 Department of Public Health (DPH) in the amount of \$783,091 for the period of January 1,
12 2017, through December 31, 2017; and

13 WHEREAS, The full project period of the grant starts on January 1, 2016, and ends on
14 December 31, 2020, with years three, four, and five subject to availability of funds and
15 satisfactory progress of the project; and

16 WHEREAS, The purpose of this project is to continue on-going bio-behavioral
17 surveillance activities among populations at high risk for HIV infection in San Francisco; and

18 WHEREAS, This activity monitors changes in HIV prevalence, incidence and related
19 risk behaviors; and

20 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

21 WHEREAS, A request for retroactive approval is being sought because DPH received
22 the full award agreement on January 13, 2017, for a project start date of January 1, 2017; and

23 WHEREAS, The AAO budget for FY2016-2017 was approved in the amount of
24 \$487,886; and

1 WHEREAS, An increase of \$295,205 from \$487,886 was approved for the period of
2 January 1, 2017, through December 31, 2017 for a total amount of \$783,091; and

3 WHEREAS, The budget includes a provision for indirect costs in the amount of
4 \$44,298; now, therefore, be it

5 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
6 in the amount of \$783,091 from Centers for Disease Control and Prevention; and, be it


7 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
