3 Resolution determining that the issuance of a Type 40 license to George Rush for
4 the Roxie Theatre, located at 3117-16th Street (District 6), will serve the public
5 convenience or necessity of the people of the City and County of San Francisco,
6 in accordance with Section 23958.4 of the California Business and Professions
7 Code, and recommending that the California Department of Alcoholic Beverage
8 Control impose conditions on the issuance of the license.

10 WHEREAS, George Rush is seeking the issuance of a Type 40 license for the
11 Roxie Theatre, located at 3117-16th Street; and,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department has filed a protest with the Department of
15 Alcoholic Beverage Control under Section 24013 of the California Business and
16 Professions Code, recommending that the Department of Alcoholic Beverage Control
17 issue the liquor license with conditions; and

18 WHEREAS, The conditions recommended by the Police Department are: (1)
19 Sales, service and consumption of alcoholic beverages shall be permitted only between
20 the hours of 11:00 a.m. and 1:00 a.m. daily; (2) Sales service and consumption of
21 alcoholic beverages is permitted only on days that the theater has a bona fide theater
22 performance or movie; (3) Sales, service and consumption of alcoholic beverages shall
23 be permitted only to the lobby area as depicted in the ABC-257 dated 5/18/11; (4)
24 Sales, service, and consumption of alcoholic beverages shall be made only from
25

1 stationary bar or waiter/waitress services, and shall not be sold, served or delivered to
2 customers by individual ambulatory vendors; (5) The petitioner shall post sign(s),
3 measuring no less than 12 x12 inches with lettering no smaller than two (2) inches in
4 height that read "No Alcoholic Beverages beyond This Point" at all permitted exits,
5 entrances and entrances to the theatre seating area as depicted on the ABC-257 dated
6 5/18/11; (6) An employee or security guard shall be assigned the responsibility of
7 ensuring all alcoholic beverages remain inside the permitted lobby area whenever the
8 privileges of the ABC license are being exercised; (7) The sale of alcoholic beverages
9 for consumption off the premises is strictly prohibited; (8) Beer shall be dispensed, sold
10 and served only in containers being no larger than 16 ounce capacity. These
11 containers shall bear distinctive markings making them easily distinguishable from other
12 non-alcoholic beverages provided by the licensee; (9) No person may be served and/or
13 sold more than two containers of beer; (10) The petitioner(s) shall be responsible for
14 maintaining free of litter the area adjacent to the premises over which they have control,
15 as depicted on the ABC-257 dated 5/18/11; (11) Loitering (loitering is defined as "to
16 stand idly about; linger aimlessly without lawful business") is prohibited on any
17 sidewalks or property adjacent to the licensed premises under the control of the
18 licensee as depicted on the ABC-257; (12) No noise shall be audible beyond the area
19 under the control of the licensee(s) as defined by the ABC-257 dated 5/15/11; (13) The
20 exterior of the premises shall be equipped with lighting of sufficient power to illuminate
21 and make easily discernible the appearance and conduct of all persons on or about the
22 premises. Additionally, the position of such lighting shall not disturb the normal privacy
23 and use of any neighboring residences; and (14) The interior lighting maintain therein
24 shall be sufficient to make discernible the appearance and conduct of all persons and

1 patrons in that portion of the premises where alcoholic beverages are sold, served,
2 delivered or consumed; now, therefore, be it

3 RESOLVED, That in accordance with Section 23958.4 of the California Business
4 and Professions Code, the Board of Supervisors of the City and County of
5 San Francisco hereby determines for the foregoing reasons that the issuance of a Type
6 40 license to George Rush for the Roxie Theatre, located at 3117-16th Street, will serve
7 the public convenience or necessity of the people of the City and County of
8 San Francisco; and

6. An employee or security guard shall be assigned the responsibility of ensuring all alcoholic beverages remain inside the permitted lobby area whenever the privileges of the ABC license are being exercised.
7. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
8. Beer shall be dispensed, sold and served only in containers being no larger than 16 ounce capacity. These containers shall bear distinctive markings making them easily distinguishable from other non-alcoholic beverages provided by the licensee.
9. No person may be served and/or sold more than two containers of beer.
10. The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control, as depicted on the ABC-257 dated 5/18/11.
11. Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257.
12. No noise shall be audible beyond the area under the control of the licensee(s) as defined by the ABC-257 dated 5/15/11.
13. The exterior of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the premises. Additionally, the position of such lighting shall not disturb the normal privacy and use of any neighboring residences.
14. The interior lighting maintain therein shall be sufficient to make discernible the appearance and conduct of all persons and patrons in that portion of the premises where alcoholic beverages are sold, served, delivered or consumed.

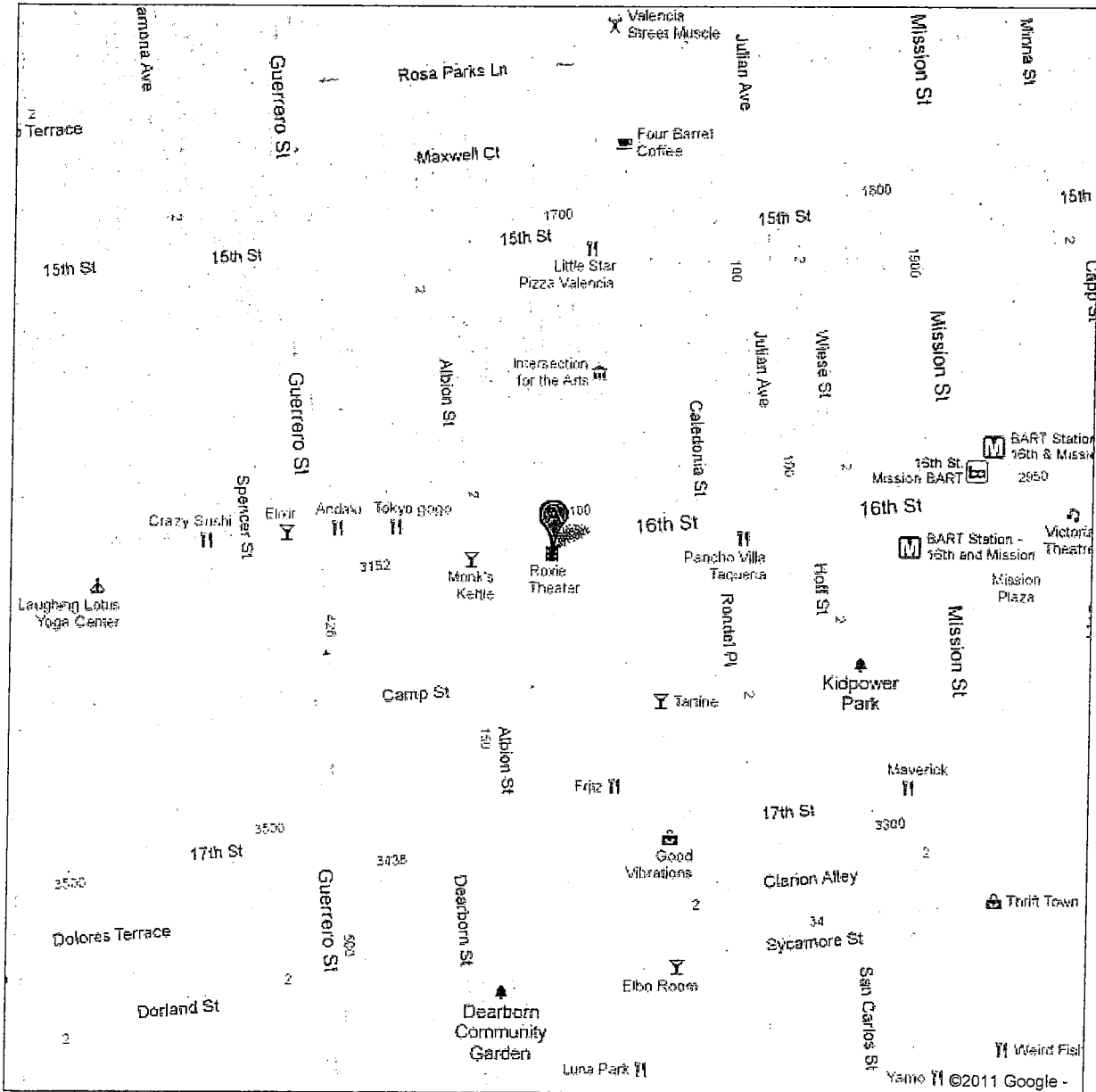

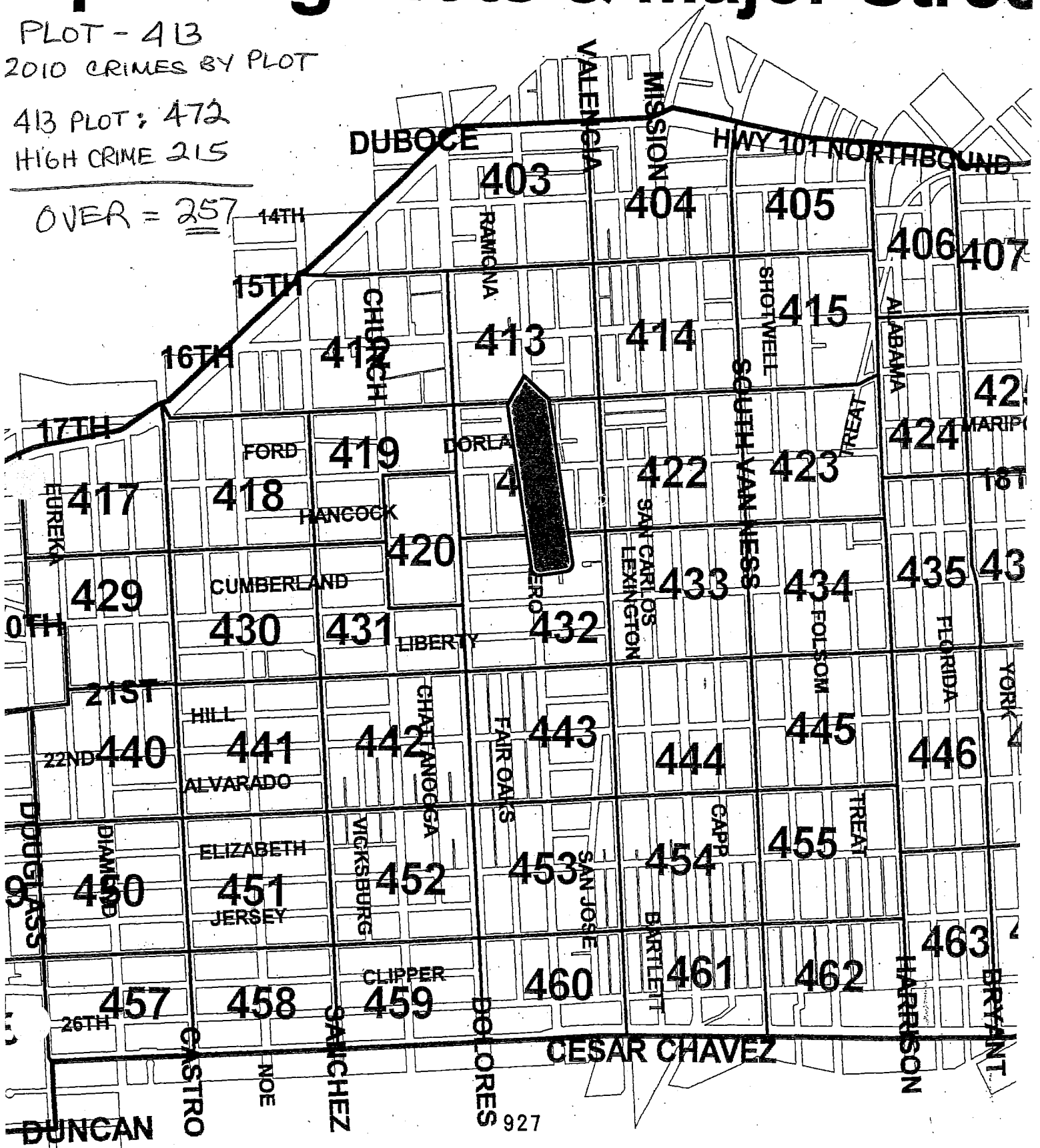

2010 CRIMES BY PLOT

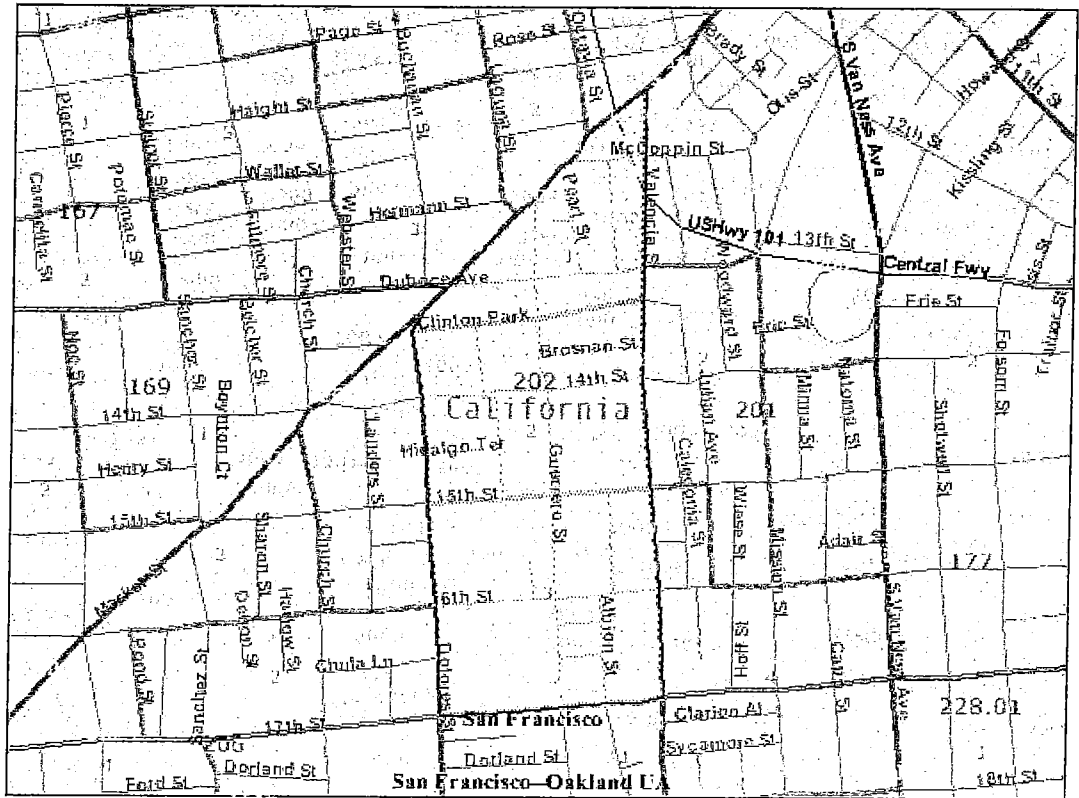

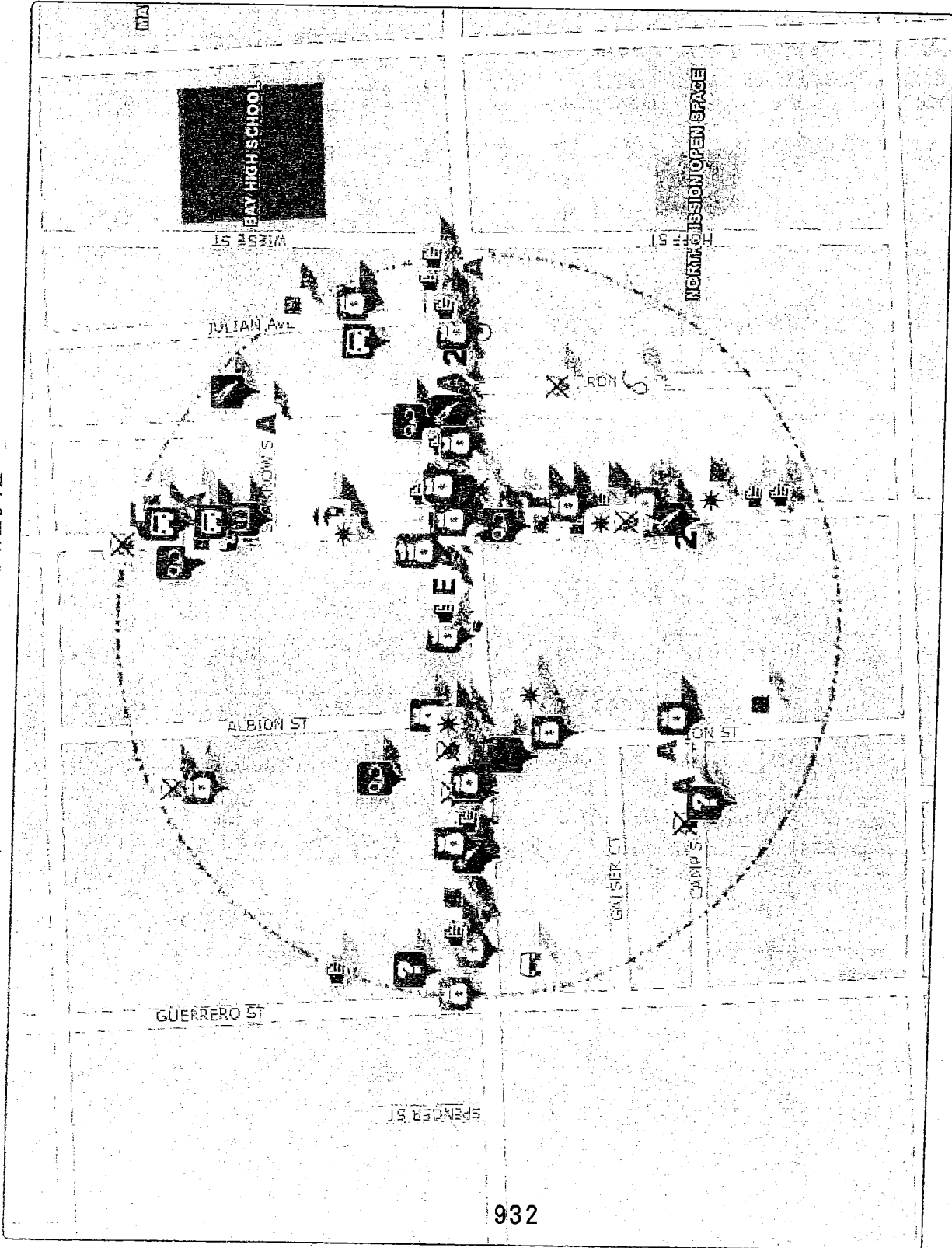

To the Clerk of the Board:

I am the legal representative for the Roxie Theater, and am writing to you on its behalf to request a public convenience and necessity resolution from the San Francisco Board of Supervisors regarding the Roxie's request for an alcohol license.

An alcohol license for the Roxie Theater will serve the public convenience and necessity in the Mission neighborhood as well as citywide for the following reasons:

The Roxie is a California non-profit corporation and has 501(c)(3) status. Over the past year, the Roxie has used its non-profit status to obtain day-use permits for on-site alcohol sales. The response from the community was so positive that the Roxie would like to make alcohol sales on its premises permanent. During this time, neither the Roxie's neighbors nor anybody else within the subdistrict has complained about loitering, public drunkenness, or any other problems related to the consumption of alcohol on the Roxie's premises. Furthermore, the sale of beer has brought in much needed funds to the non-profit theater, which has been serving the city of San Francisco for over a century.

It is a growing concern in San Francisco that single-screen theaters are dying. San Francisco is one of the few American cities that still has neighborhood movie theaters. Theaters like the Roxie live on as focal points of community discourse and assembly. The Roxie seeks to provide a venue for the little picture, the films and documentaries that help educate the public about important issues large-studio films rarely address. Without a place like the Roxie Theater, these films will not have a chance in the current market. An alcohol license for the Roxie will help the theater stay financially afloat and allow it to continue to provide a venue where the community can see the important small films, which are rarely, if ever, showcased at the Megaplex.

The subdistrict legislation already allows Non-Profit Theaters under Section 781.8(c)(2) to obtain alcohol licenses. These non-profit theaters are provided with such licenses because they require the extra income from alcohol sales to remain operational. While the Roxie Theater is also a non-profit theater, the legislation requires that the non-profit theater show "any act, play, revue, pantomime, scene, song, dance act." The Roxie,

however, only presents movies. This distinction is the only portion of the legislation that prevents the Roxie from obtaining a liquor license.

The Roxie has been around for 102 years and loves serving its local community and the larger community of San Francisco. Neighborhood theaters like the Red Vic in Haight-Ashbury have already had to close their doors because they were not profitable. An alcohol license for the Roxie would help prevent this historic San Francisco landmark from having to shut down as well.

For the reasons stated above, the Roxie respectfully requests that the Clerk of the Board permit a public convenience and necessity resolution.
