4 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
5 **accept and expend retroactively a grant allocation in the amount of \$766,187 from the**  
6 **California Department of Health Services (CDHS) to further develop and implement**  
7 **plans for public health preparedness and response to bioterrorism and to enter into an**  
8 **agreement for the use of these funds; for the period of July 1, 2002 to June 30, 2003.**

10 WHEREAS, SFDPH has applied for and been awarded a grant allocation from CDHS  
11 in the amount of \$766,187 to further develop and implement plans for public health  
12 preparedness and response to bioterrorism; and,

13 WHEREAS, As a condition of receiving the grant allocation funds, CDHS requires the  
14 City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of  
15 the Board of Supervisors in File No. 021674, which is hereby declared to be a part  
16 of this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$62,885; now,  
18 therefore, be it


19 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a  
20 grant allocation in the amount of \$766,187 from CDHS; and, be it

21 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
22 grant allocation funds in accordance with the requirements set forth in the Agreement  
23 pursuant to San Francisco Administrative Code section 10-170-1; and, be it

24 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
25 agreement on behalf of the City; and, be it

1 FURTHER RESOLVED, That the Controller is directed to designate the positions  
2 funded under this agreement as "G" or grant-funded positions which would terminate when  
3 the agreement expires.
