

1 [Urging passage of SB 1154]

2 URGING THE CALIFORNIA STATE LEGISLATURE AND GOVERNOR DAVIS TO  
3 APPROVE SENATE BILL 1154 TO GUARANTEE FUNDING FOR THE TREATMENT OF  
4 BREAST AND GYNECOLOGICAL CANCERS FOR UNINSURED WOMEN.

6 WHEREAS, Breast cancer is the most commonly diagnosed cancer among women;  
7 and,

8 WHEREAS, Nearly 180,000 American women were diagnosed with breast cancer in  
9 1998, and over the past 30 years, breast cancer incidence has been rising at approximately  
10 one percent annually; and,

11 WHEREAS, The San Francisco Bay Area has one of the highest rates of breast cancer  
12 in the world; and,

13 WHEREAS, The California State Legislature is currently considering Senate Bill 1154,  
14 establishing the California Breast and Gynecological Cancer Treatment Program, which was  
15 introduced by Senator Speier; and,

16 WHEREAS, Senate Bill 1154 will provide breast and cervical cancer treatment to low-  
17 income working women who would otherwise be unable to obtain treatment; and,

18 WHEREAS, Senate Bill 1154 is on file with the Clerk of the Board of Supervisors in  
19 File No. 000245 ; now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
21 endorses Senate Bill 1154 and urges the Legislature and Governor to approve this  
22 legislation; and, be it

23 FURTHER RESOLVED, That a copy of this resolution be forwarded to his Honor, the  
24 Mayor, with a request that he transmit copies to the delegation from San Francisco in the

1 State Legislature, as well as Governor Davis, with a request they take all action necessary to  
2 achieve the objectives of this resolution.




