7 WHEREAS, Saint Francis Memorial Hospital and St. Mary's Medical Center have been
8 providing care to the people of the City and County of San Francisco for more than 140 years;
9 and,

10 WHEREAS, Both hospitals are members of Catholic Healthcare West (CHW), a major
11 provider of hospital services based in San Francisco; and,

12 WHEREAS, CHW is committed to the promotion of public / private partnerships whose
13 goal is to enhance and protect the provision of health care services, particularly for the
14 medically underserved; and,

16 WHEREAS, Saint Francis and St. Mary's hospitals have been engaged with the San
17 Francisco Department of Public Health (The Department) in identifying and evaluating
18 potential areas of collaboration; and,

19 WHEREAS, The Department and the hospitals have established collaborative
20 relationships that have improved access to health care services through increased primary
21 care referrals and integration with the Department's Lifetime Clinical Record, among other

1 WHEREAS, CHW has developed a leading patient financial assistance policy to
2 address increasing health care costs and protect access to care for people who find it difficult
3 to pay for health services; and,

4 WHEREAS, CHW has developed an innovative tool, the Community Needs Index
5 (CNI), to accurately identify community-wide health needs so that resources can be directed
6 to improve health in order to avoid unnecessary hospitalizations; and,

7 WHEREAS, The Department and the hospitals have signed a formal Memorandum of
8 Understanding (MOU) to promote further joint service planning that could lead to expanded
9 relationships focused on securing safety-net services to vulnerable populations; now,
10 therefore, be it

11 RESOLVED, That CHW, Saint Francis and St. Mary's hospitals are to be commended
12 for their commitment to working with the Department to protect and enhance the provision of
13 health care services to vulnerable populations, and therefore be it

14 FURTHER RESOLVED, That other hospital service providers within the City and
15 County of San Francisco be encouraged to emulate these efforts and engage with the
16 Department in developing innovative and long-lasting public – private partnerships vital to the
17 maintenance of critical health care services.




