2 - \$36,118,233]

3 **Resolution authorizing the San Francisco Department of Public Health to submit an**  
4 **application to continue to receive funding for the “HIV/AIDS Emergency Relief Grant**  
5 **Programs (Ryan White Programs, Part A)” Grant from the Health Resources Services**  
6 **Administration, requesting \$36,118,233 in HIV Emergency Relief Program funding for**  
7 **the San Francisco Eligible Metropolitan Area from March 1, 2011, through February 28,**  
8 **2012.**

10 WHEREAS, Section 10.170.(b) of the San Francisco Administrative Code requires  
11 Board review of proposed annual or otherwise recurring grant applications of \$5,000,000 or  
12 more prior to their submission; and,

13 WHEREAS, DPH is currently a recipient of the “HIV Emergency Relief Grant Program”  
14 grant in the amount of approximately \$26,009,568 from the HRSA for fiscal year 2010; and,

15 WHEREAS, For this round of funding, DPH was instructed by HRSA to submit an  
16 application request in the amount of \$36,118,233; and,

17 WHEREAS, DPH uses these funds to cover a multitude of health services to HIV  
18 positive persons residing in the three counties within the San Francisco Eligible Metropolitan  
19 Areas (EMA); and,

20 WHEREAS, Ordinance No. 265-05 requires that City Departments submit applications  
21 for approval at least 60 days prior to the grant deadline for review and approval; and,

22 WHEREAS, HRSA released the application announcement on August 30, 2010 with a  
23 due date of October 18, 2010 allowing just 32 days for the entire process; and,

24 WHEREAS, in the interest of timeliness, DPH is making this request for approval by  
25 submitting its most recent draft of the grant application, also including supporting documents

1 as required, all of which are on file with the Clerk of the Board of Supervisors in File No.  
2 101253, which is hereby declared to be part of the Resolution as if set forth  
3 fully herein; and, now, therefore, be it

4 RESOLVED, That the Board of Supervisors hereby approves DPH's application  
5 submission to HRSA for the "HIV Emergency Relief Grant Program (Ryan White Programs,  
6 Part A)" grant for the funding period of March 1, 2011 through February 28, 2012, to be  
7 submitted no later than October 18, 2010.
