FURTHER MOVED, That the sponsor and opponent of the measure submitted to the voters for the February 8, 2008 Election, who are authorized by this motion to submit argument, may authorize or assign to any other person(s) under the provisions of the San Francisco Elections Code Sections 530 and 550 (c) and (d) the right to submit the proponent or opponent ballot argument and/or respective rebuttal argument.
