2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **NO U-TURN - ESTABLISH**

7 The Embarcadero, northbound, at Broadway

8 **TOW-AWAY, NO STOPPING, 4 PM - 6 PM, MONDAY THROUGH FRIDAY - RESCIND**
9 **TOW-AWAY, NO STOPPING, 3 PM - 7 PM, EVERYDAY - ESTABLISH**

10 Masonic Avenue, west side, from Geary Boulevard to 150 feet northerly (150-foot
zone, change in effective days and hours only)

11 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

12 4th Street, east side, from Howard Street to a point ³³²~~320~~ feet south of Mission Street
(320-foot zone)

13 4th Street, east side, from Mission Street to ²¹²~~200~~ feet southerly (200-foot zone)

14 San Jose Avenue, west side, from Baden Street to 40 feet northerly (40-foot zone)

4th Street, east side, from Mission Street to 212 feet southerly (200-foot zone)




