10 WHEREAS, Under current City regulatory and rate setting procedures, only
11 residential refuse and recycling rates can be regulated; and

12 WHEREAS, Currently both refuse companies (Sunset Scavenger and Golden
13 Gate Disposal) combine residential and commercial waste collection; and

14 WHEREAS, It may be to the City's benefit to understand, and potentially regulate
15 commercial rates, in addition to the existing residential rates, and

16 WHEREAS, Sunset Scavenger, Golden Gate Disposal & Recycling Company and
17 Sanitary Fill Company (Norcal) submitted an application in January of 2001 for an
18 increase in the rates for collection and disposal of refuse from residences, flats and
19 apartments in San Francisco; and

20 WHEREAS, The City's Rate Review Board established new residential rates which
ve as of July 1, 2001; now, therefore, be it

, That the Board of Supervisors of the City and County of San Francisco
e Budget Analyst undertake an expedited review of the audited financial
Sunset Scavenger Company, Golden Gate Disposal, Sanitary Fill


