8 Be it ordained by the People of the City and County of San Francisco:


9 Section 1. The San Francisco Administrative Code is hereby amended by adding
10 Sections 2A.250, to read as follows:

11 Sec. 2A.250. DEPARTMENT OF THE MEDICAL EXAMINER.

12 (a) Department of the Medical Examiner. There shall be a Department of the Medical
13 Examiner. The City Administrator, with the concurrence of the Mayor, shall appoint and may remove a
14 Medical Examiner, who shall meet the qualifications for Medical Examiner as provided by state law.
15 The Medical Examiner shall serve as department head and appointing officer for the Department, and
16 shall succeed to all of the duties of the Coroner. The Department shall include such officers and
17 employees as are authorized pursuant to the budgetary and fiscal provisions of the Charter.

18 (b) Duties and Functions. The Department shall be responsible for the duties of the Medical
19 Examiner as provided by state law, and such other duties and functions as assigned pursuant to the
20 Charter or by ordinance.
