

1 APPROVING ABANDONMENT OF A PORTION OF THE SERVICE ON LINE 33-STANYAN.  
2 ESTABLISHMENT OF SUBSTITUTE SERVICE.

3 WHEREAS, The Board of Supervisors is in receipt of Public Transportation Resolution No.  
4 99-029, adopted April 6, 1999, which resolution reads as follows:

5 WHEREAS, There is a clear need to provide direct transit service to the 16<sup>th</sup> Street BART station  
6 with the 33-STANYAN in both directions; and,

7 WHEREAS, Improvements have been made to the overhead wire system that will facilitate the  
8 operation of trolley coaches turning onto and from Mission Street at 18<sup>th</sup> and at 16<sup>th</sup> streets; and,

9 WHEREAS, The Department of Parking and Traffic has agreed to move the center line of 16<sup>th</sup> Street  
10 to the north to allow buses to turn right from northbound Mission Street to eastbound 16<sup>th</sup> Street and  
11 to install a bus stop on 16<sup>th</sup> Street on the southeast corner; and,

12 WHEREAS, The bus stop changes accompanying the reroute were approved at the Parking and  
13 Traffic hearing on February 19, 1999, now, therefore, be it

14 RESOLVED, That the Public Transportation Commission does hereby authorize the Public  
15 Transportation Department to abandon the portion of the 33-STANYAN trolley coach route on 18<sup>th</sup>  
16 Street between Mission Street and South Van Ness Avenue and on South Van Ness Avenue between  
17 18<sup>th</sup> Street and 16<sup>th</sup> Street and to establish a new eastbound route on Mission Street between 18<sup>th</sup>  
18 Street and 16<sup>th</sup> Street and on 16<sup>th</sup> Street between Mission Street and South Van Ness Avenue; and,  
19 be it further

20 RESOLVED, That these changes will not be implemented until necessary changes to lane  
21 delineations and parking be made by the Department of Parking and Traffic, and be it further

22 RESOLVED, That this Commission respectfully requests the Board of Supervisors to not  
23 disapprove the aforementioned changes in Service;

24 Now, therefore, be it

25 RESOLVED, That the Board of Supervisors does, hereby, approve the aforementioned partial  
abandonment of service on line 33-STANYAN and the establishment of substitute service.




