5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the  
6 following intersections are hereby designated as "STOP" intersections, and the  
7 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"  
8 signs to be installed thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

10 20th and Sanchez Streets, stopping the Liberty Street approaches to 20th Street;

11 Manzanita Avenue and Euclid Avenue, stopping Manzanita Avenue;

12 Iris Avenue and Euclid Avenue, stopping Iris Avenue;

13 King Street at Division Street, stopping southbound King Street;

14 Green and Montgomery Streets, stopping Montgomery Street at Green Street,  
15 making this uncontrolled intersection a two-way STOP.

16 Crestlake Drive and Yorba Street, making this Y-intersection an All-Way STOP.

18 Categorically exempt from Environmental  
19 Review Class 1(c)(9) changes in the traffic and  
20 parking regulations where such changes do not  
21 establish a higher speed limit or result in more  
22 than a negligible increase in the use of the  
23 street.
