Quality, affordable child care allows parents to work each day with peace of mind, knowing their children are in a safe, nurturing and age-appropriate environment. Unfortunately, budget deficits threaten the continued availability of quality affordable child care. The Week of the Young Child gives us an opportunity to highlight the needs of our young children and is the best time for us to advocate for quality child care programs and other services for children and families. **Without this advocacy, programs that help families and their children may not be given priority and we cannot leave these to chance. To the San Francisco Board of Supervisors,

I am writing to commend the resolution being voted on today in recognition of the *Week of the Young Child*, and importantly for committing your time to get to know the programs in your community firsthand. Early care and education is offered in a diverse array of programs from family child care homes to small centers in residential communities, to churches, non-profits, co-operatives, Head Starts, and public schools. We appreciate each of you who have or are about to take time getting to know programs in your district.

These programs have managed to offer the needed nurturing and learning environment for children and support families without any public funds or with public funds that do not meet the cost of the service they provide. How have they done it? Teachers and staff working at too low wages—wages below the cost of living, and too high parent fees have told the story of early care and education for too long—making the much needed service unstable and out of reach for too many. At community meetings among ECE providers we discussed both the successes of the new funds, and the highest needs still to be met. One resonant comment was that the amount of staff time—in a field with a deficit of staff—needed to hold fundraisers. Imagine if that time could be spent developing and providing excellent programming instead.

San Francisco voters supported an opportunity to change this. After waiting through a lawsuit to start these funds flowing to our community, for the first time educators feel hopeful we might be able to attract more educators to the field and provide the service in the way that San Francisco's 0-5 year olds deserve and need. The first five years pass quickly—alongside your recognition of the *Week of the Young Child*, stand with the needs of our youngest, and what is needed to provide these fundamental services—***don't let funds intended for San Francisco's youngest be diverted to fill the deficit.***

We appreciate your attention to building a great foundation for our community now and our future.

With that being said, unfortunately, the Monday following the Week of the Young Child, our SF child care community was notified that the city wants to pause its Prop C contribution to close about 1/3rd of San Francisco's \$290M budget deficit. **The city cannot close the deficit on the backs of the city's youngest children and their struggling families.** It is truly concerning the city would be okay with using funding allocated for 0 -5 children and their struggling families to do so. In keeping with the Week of the Young Child we hope to have your support in finding an alternative funding source to close this gap, I ask everyone to keep this in mind as we move out of this time, thank you!

Annually, our organization serves families and educators in San Francisco through partnerships with 400 classrooms, 101 family childcare centers, and dozens of other community-based organizations.

I am writing to commend the resolution being voted on today recognizing the Week of the Young Child. As we know, the years from birth to five is a critical time, and the quantity and quality of experiences that children are exposed to during this time has the potential to shape their future outcomes. A comprehensive mixed delivery model and two-generation approach, that provides care

and learning for children while expanding the capacity of the adults in their life, are both key components of a thriving early childhood ecosystem.
