11 Francisco, et al., United States District Court, Case No. C13-3674 DMR by the payment of  
12 \$50,000.

13 Section 2. The above-named action was filed in the United States District Court on  
14 August 8, 2013, and the following parties were named in the lawsuit: Plaintiff Elvis Taouil and  
15 Defendants City and County of San Francisco, Ross Mirkarimi, and Vincent Calvarese.


