6 **By And Through His Guardian Ad Litem Ann Precilla Luyon v. City and County of San**
7 **Francisco, et al.; the lawsuit involves an alleged personal injury caused by an alleged**
8 **dangerous condition of public property.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Elijah Williams, a Minor, By And
13 Through His Guardian Ad Litem Ann Precilla Luyon v. City and County of San Francisco, et
14 al., San Francisco Superior Court, Case No. CGC-22-600440 by the payment of \$37,500.

15 The lawsuit involves an alleged personal injury caused by an alleged dangerous condition of
16 public property.

17 Section 2. The above-named action was filed in San Francisco Superior Court on June
18 28, 2022, and the following parties were named in the lawsuit: Plaintiff Elijah Williams,
