7 the San Francisco Board of Supervisors have co-sponsored "Speak Up for Kids Day" at City
8 Hall; and

9 WHEREAS, Speak Up for Kids Day is a legislative open house enabling parents, youth,
10 diverse community groups and other city residents to communicate directly with local elected
11 representatives; and

12 WHEREAS, This unique civic engagement opportunity helps foster appreciation for,
13 and participation in, the democratic process by parents, community groups from underserved
14 communities and middle-and-high school age youth; and

15 WHEREAS, The Campaign for Kids is an alliance of child advocacy coalitions located in
16 each of San Francisco's Supervisorial Districts; and

17 WHEREAS, Speak Up for Kids Day focuses attention on the needs of San Francisco's
18 Children from each district and City-wide; and

19 WHEREAS, Every member of the Board of Supervisors has a vested interest in being
20 accessible to, and hearing concerns of, local residents who might otherwise feel alienated
21 from City government; and

22 WHEREAS, Members of the Board of Supervisors can improve the quality of life for
23 children and families by increasing the stock of affordable housing, increasing child care for
24 working families, fostering youth development opportunities, expanding teen health services in
25 high school, improving parks and playgrounds, and ensuring resource for healthy communities

1 WHEREAS, Informed and involved constituents are absolutely essential for a truly
2 representative government, Now, Therefore, Be It

3 RESOLVED, That the San Francisco Board of Supervisors hereby proclaims




