WHEREAS, The South of Market ("SoMa") neighborhood faces significant challenges, including limited pedestrian and cycling routes, a lack of green space, seasonal flooding, and air pollution, which disproportionately impacts the health of the community, as identified in San Francisco's Heating and Air Quality Resilience Study; and

WHEREAS, The SoMa Under Freeway Park project ("Project") seeks to rectify these challenges by exploring the potential of underutilized land between 4th and 6th Streets, and Harrison and Bryant Streets, by addressing flooding, expanding the urban tree canopy, improving transportation safety, and creating green spaces for recreation; and

WHEREAS, The Project is part of the broader Central SoMa Area Plan of 2018 and builds upon the Department of Public Works' ("Department") recent successes, such as launching and operating the San Francisco Street Tree Nursery at 5th and Harrison Streets, and the SoMa Under Freeway Park aims to provide long-term environmental and community benefits; and

WHEREAS, On July 9, 2024, the California Department of Transportation ("Caltrans" or "Grantor") awarded Public Works a grant of \$626,000 through the Fiscal Year 2024-25
