3 **Ordinance authorizing settlement of the lawsuit filed by Elsa Acevedo Lubguban**
4 **against the City and County of San Francisco for \$175,000; the lawsuit was filed on**
5 **March 23, 2020, in San Francisco Superior Court, Case No. CGC-20-583887; entitled**
6 **Elsa Acevedo Lubguban v. City and County of San Francisco, et al.; the lawsuit**
7 **involves alleged personal injury from an alleged dangerous condition of public**
8 **property.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Elsa Acevedo Lubguban v. City and
13 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-583887 by
14 the payment of \$175,000. The lawsuit involves alleged personal injury from an alleged
15 dangerous condition of public property.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 March 23, 2020, and the following parties were named in the lawsuit: Plaintiff Elsa Acevedo
18 Lubguban; Defendants City and County of San Francisco, Pacific Gas and Electric Co.,
19 William M. Schwarz, and Dale Dalton.
