1 [Condemning ICE for Loss of Life, Urging Accountability Measures and Corrective Action to
2 Prevent Further Loss of Life and Reaffirming Commitment to Sanctuary City]

3 **Resolution condemning Immigration and Customs Enforcement (ICE) for actions that
4 have led to loss of life; urging state and federal partners to call for a third-party
5 investigation on all deaths that have occurred as a result of actions taken by ICE
6 officers; calling for a moratorium on ICE detention until a third-party investigation be
7 conducted and corrective action be implemented; and reaffirming San Francisco's
8 commitment to upholding Sanctuary City policies.**

10 WHEREAS, Since the beginning of 2025, there has been a significant increase in
11 Immigration and Customs Enforcement (ICE) actions throughout the United States, including
12 locally in San Francisco; and

13 WHEREAS, These enforcement actions have led to reports of kidnappings,
14 disappearances, abductions, and terror, including violence perpetrated upon individuals under
15 ICE custody; and

16 WHEREAS, Throughout 2025, 32 individuals died while in ICE custody and three
17 individuals were fatally shot by ICE officers, eliciting profound outrage and despair at the
18 inability of ICE to properly observe due process and care for individuals under custody; and

19 WHEREAS, In 2025, thirty-two people died while in ICE custody, making it the
20 deadliest year in more than twenty years; and

21 WHEREAS, On January 23, 2025, Genry Ruiz Guillén died at 29 years old while in ICE
22 custody in Hialeah, Florida; and

23 WHEREAS, On January 29, 2025 Serawit Gezahegen Dejene died at 45 years old
24 while in ICE custody in Phoenix, Arizona; and

1 WHEREAS, On February 20, 2025, Maksym Chernyak died at 44 years old while in
2 ICE custody in Miami, Florida; and

3 WHEREAS, On February 23, 2025, Juan Alexis Tineo-Martinez died at 44 years old
4 while in ICE custody in San Juan, Puerto Rico; and

5 WHEREAS, On April 8, 2025, Brayan Garzón-Rayó died at 27 years old while in ICE
6 custody in Rolla, Missouri; and

7 WHEREAS, On April 16, 2025, Nhon Ngoc Nguyen died at 55 years old while in ICE
8 custody in El Paso, Texas; and

9 WHEREAS, On April 25, 2025, Marie Ange Blaise died at 44 years old while in ICE
10 custody in Pompano Beach, Florida; and

11 WHEREAS, On May 5, 2025, Abelardo Avellaneda Delgado died at 68 years old while
12 in ICE custody while being transported from a local jail in Statenville, Georgia to a detention
13 center in Lumpkin, Georgia; and

14 WHEREAS, On June 7, 2025, Jesus Molina-Veya died at 45 years old while in ICE
15 custody in Lumpkin, Georgia; and

16 WHEREAS, On June 23, 2025, Johnny Noviello died at 49 years old while in ICE
17 custody at the Bureau of Prisons' federal detention center in Miami, Florida; and

18 WHEREAS, On June 26, 2025, Isidro Pérez died at 75 years old while in ICE custody
19 in Florida; and

20 WHEREAS, On July 19, 2025, Tien Xuan Phan died at 55 years old while in ICE
21 custody in Live Oak, Texas; and

22 WHEREAS, On August 5, 2025, Chaofeng Ge died at 32 years old while in ICE
23 custody in Pennsylvania; and

24 WHEREAS, On August 31, 2025, Lorenzo Antonio Batrez Vargas died at 32 years old
25 while in ICE custody in Florence, Arizona; and

1 WHEREAS, On September 8, 2025, Oscar Rascon Duarte died at 58 years old while in
2 ICE custody in Mesa, Arizona; and

3 WHEREAS, On September 12, 2025, Silverio Villegas González, 38 years old, was
4 fatally shot by an ICE officer in Chicago, Illinois; and

5 WHEREAS, On September 18, 2025, Santos Banegas Reyes died at 42 years old
6 while in ICE custody in Nassau County, New York; and

7 WHEREAS, On September 22, 2025, Ismael Ayala-Uribe died at 39 years old while in
8 ICE custody in Adelanto, California; and

9 WHEREAS, On September 24, 2025, Norlan Guzman-Fuentes was killed at 37 years
10 old when a gunman opened fire at the ICE office that he was being held in custody at near
11 Dallas, Texas; and

12 WHEREAS, On September 29, 2025, Miguel Ángel García Medina was killed at 31
13 years old when a gunman opened fire at the ICE office that he was being held in custody at
14 near Dallas, Texas

15 WHEREAS, On September 29, 2025, Huabing Xie died while in ICE custody in
16 Calexico, California; and

17 WHEREAS, On October 4, 2025, Leo Cruz-Silva died at 34 years old while in ICE
18 custody in Ste. Genevieve, Missouri; and

19 WHEREAS, On October 11, 2025, Hasan Ali Moh'D Saleh died at 67 years old while in
20 ICE custody in Miami, Florida; and

21 WHEREAS, On October 23, 2025, Josué Castro Rivera died at 25 years old while
22 trying to flee ICE agents in Virginia; and

23 WHEREAS, On October 23, 2025, Gabriel Garcia Aviles died at 54 years old while in
24 ICE custody in Victorville, California; and

25

1 WHEREAS, On October, 25, 2025, Kai Yin Wong died at 63 years old while in ICE
2 custody in San Antonio, Texas; and

3 WHEREAS, On December 3, 2025, Francisco Gaspar-Andrés died at 48 years old
4 while in ICE custody in El Paso, Texas; and

5 WHEREAS, On December 5, 2025, Pete Sumalo Montejo died at 72 years old while in
6 ICE custody in Harlingen, Texas; and

7 WHEREAS, On December 6, 2025, Shiraz Fatehali Sachwani died at 48 years old
8 while in ICE custody in Fort Worth, Texas; and

9 WHEREAS, On December 12, 2025, Jean Wilson Brutus died at 41 years old while in
10 ICE custody in Newark, New Jersey; and

11 WHEREAS, On December 14, 2025, Fouad Saeed Abdulkadir died at 46 years old
12 while in ICE custody in Philipsburg, Pennsylvania; and

13 WHEREAS, On December 14, 2025, Delvin Francisco Rodriguez died at 39 years old
14 while In ICE custody in New Orleans, Louisiana; and

15 WHEREAS, On December 15, 2025, Nenko Stanev Gantchev died at 56 years old
16 while in ICE custody in Baldwin, Michigan; and

17 WHEREAS, On December 31, 2025, Keith Porter Jr, 43 years old, was fatally shot by
18 an off-duty ICE officer in Los Angeles, California; and

19 WHEREAS, On January 7, 2026, Renee Nicole Macklin Good, 37 years old, was fatally
20 shot by an ICE agent in Minneapolis, Minnesota; and

21 WHEREAS, Many of these deaths are still under investigation, leaving families and
22 communities without adequate answers surrounding the circumstances of what occurred while
23 in ICE custody; and

1 WHEREAS, These deaths don't account for the widespread reports of disappearing of
2 countless individuals or the deaths of those impacted by the stress from the rampant
3 escalation of ICE enforcement; and

4 WHEREAS, San Francisco has committed to supporting its immigrant community and
5 has reaffirmed its commitment to upholding Sanctuary City policies; now, therefore, be it

6 RESOLVED, That the San Francisco Board of Supervisors condemns ICE for actions
7 that have led to the loss of life, both in instances of the fatal shootings and in-custody deaths;
8 and, be it

9 FURTHER RESOLVED, That the Board of Supervisors urges state and federal
10 partners to call for a third-party investigation on all deaths that have occurred as a result of
11 actions taken by ICE officers; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors calls for a moratorium on ICE
13 detention until a third-party investigation be conducted and correction action be implemented;
14 and, be it

15 FUTHER RESOLVED, That the Board of Supervisors reaffirms again its commitment to
16 protecting Sanctuary City policies that promote public safety for the City and immigrant
17 communities.
