Hearing to consider that the transfer of a Type-20 off-sale beer and wine liquor license to Lucinda's Deli and More, LLC, doing business as Lucinda's Deli & More, located at 535 Scott Street (District 5), will serve the public convenience or necessity of the City and County of San Francisco. Exceeding 15% constitutes a change of use to a liquor store, which requires Conditional Use Authorization. Approval is also subject to the conditions of Planning Code Sec. 186. Recommend approval. Parcel 1203/002 within RH-3 (Residential-House, Three Family) Zoning District. Continuation of existing General Grocery use (d.b.a. Lucinda's Deli & More) permitted in a NC-1 Zoning District (PC. Sec. 710). Meets requirements for continued limited and nonconforming commercial use in a RH District per Planning Code Sec.186 (a)(1).

# 210059 [Supporting California State Senate Bill No. 110 (Wiener) - Recovery Incentives Act]
