11 that affect immigrants residing in San Francisco, for the unexpired portion of a two-year term  
12 ending June 6, 2012.

13         Samer Danfoura, seat 3, succeeding Solomon Jones, term expired, must have a  
14 demonstrated knowledge of and interest in the health, human service, educational, or  
15 employment issues that affect immigrants residing in San Francisco, for the unexpired portion  
16 of a two-year term ending June 6, 2012.

17         Teresa Chee, seat 5, succeeding Joaquin Gonzalez, term expired, must have a  
18 demonstrated knowledge of and interest in the health, human service, educational, or  
19 employment issues that affect immigrants residing in San Francisco, for the unexpired portion  
20 of a two-year term ending June 6, 2012.

21         Elahe Enssani, seat 9, succeeding herself, term expired, must be an immigrant to the  
22 United States who is appointed in accordance with Section 4.101 of the Charter. In addition,  
23 members shall have a demonstrated knowledge of and interest in the health, human service,  
24 educational, or employment issues that affect immigrants residing in San Francisco, for the  
25 unexpired portion of a two-year term ending June 6, 2012.
