4 **fees for recreation programs based on the Department’s operating costs for those**
5 **programs and various other factors, including whether the program is designated for**
6 **youth, seniors, or persons with disabilities, subject to approval of the Recreation and**
7 **Park Commission; directing the Commission to update its scholarship policy to**
8 **provide for further discounts for recreation programs based on financial need; making**
9 **certain clarifying changes; and affirming the Planning Department’s determination**
10 **under the California Environmental Quality Act.**

18 Be it ordained by the People of the City and County of San Francisco:

19 Section 1. Environmental Findings.

20 The Planning Department has determined that the actions contemplated in this
21 ordinance comply with the California Environmental Quality Act (California Public Resources
22 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
23 Supervisors in File No. 250605 and is incorporated herein by reference. The Board affirms
24 this determination.

1 Section 2. Article 12 of the Park Code is hereby amended by revising Section 12.01,
 2 revising and consolidating Sections 12.02 and 12.03 as Section 12.02; deleting Sections
 3 12.15, 12.27, 12.29, 12.30, 12.39, and 12.48; and revising Sections 12.40, 12.44, and 12.45,
 4 to read as follows:

8 (a) Fees for cabins and tent sites at Camp Mather, and meal fees for overnight guests, shall be

11 (a) Authorization to Impose Fees. *The Department may set fees under this Section 12.44 for*
12 *Recreation Programs it may offer to the public, unless otherwise specified in this Article 12, subject to*
13 *the prior approval of the Recreation and Park Commission. The Department shall publish all*
14 *approved fees on its website.*

15 (b) Fees Based on Cost Recovery. *The fee for each Recreation Program shall not exceed the*
16 *estimated Operating Costs of that Program in the coming fiscal year, divided by the total number of*
17 *slots that the Department will offer in the coming year for that Program; provided, however, that (1)*
18 *the Department shall seek to recover not more than ~~50%~~75% of the estimated Operating Costs of*
19 *Programs designated for youth or seniors or persons with disabilities, with the exception of Camp*
20 *Mather, for which the fee may be based on 100% of the estimated Operating Costs; and (2) for all*
21 *other Programs the Department shall give the highest priority to recovering not more than 50% of the*

9 Section 3. Effective Date. This ordinance shall become effective 30 days after
10 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
11 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
12 of Supervisors overrides the Mayor's veto of the ordinance.

13
14 Section 4. Scope of Ordinance.

15 (a) In enacting this ordinance, the Board of Supervisors intends to amend only
16 those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation
17 marks, charts, diagrams, or any other constituent parts of the Municipal Code that are
18 explicitly shown in this ordinance as additions, deletions, Board amendment additions, and
19 Board amendment deletions in accordance with the "Note" that appears under the official title
20 of the ordinance.

21 (b) The various codified fees presented as existing Code text in Section 2 of this
22 ordinance do not necessarily reflect the fees that are currently applicable. Pursuant to Park
23 Code Section 12.20, the Controller adjusts those fees on an annual basis to reflect changes in
24 the Consumer Price Index. This ordinance is not intended to invalidate any adjustments under
25 Section 12.20 that the Controller has previously approved.

1 (c) The current fees (including any Controller adjustments to those fees) 20 shall
2 continue to apply, until a cost recovery fee is set with approval of the Recreation and Park
3 Commission under the proposed Section 12.44. Further, the deletion of sections of the Park
4 Code referencing specific program fees in Section 2 of this ordinance does not mean that the
5 Department is prohibited from charging a fee for those programs. The intent of this ordinance
6 is to allow the Department to set fees for those programs under the proposed Section 12.44
7 instead.

8
9 Section 5. Severability.

10 If any section, subsection, sentence, clause, phrase, or word of this ordinance, or any
11 application thereof to any person or circumstance, is held to be invalid or unconstitutional by a
12 decision of a court of competent jurisdiction, such decision shall not affect the validity of the
13 remaining portions or applications of the ordinance. The Board of Supervisors hereby
14 declares that it would have passed this ordinance and each and every section, subsection,
15 sentence, clause, phrase, and word not declared invalid or unconstitutional without regard to
16 whether any other portion of this ordinance or application thereof would be subsequently
17 declared invalid or unconstitutional.

REVISED LEGISLATIVE DIGEST
(Amended in Committee, 6/25/2025)

[Park Code - Recreation Program Fees]

Ordinance amending the Park Code to allow the Recreation and Park Department to set fees for recreation programs based on the Department's operating costs for those programs and various other factors, including whether the program is designated for youth, seniors, or persons with disabilities, subject to approval of the Recreation and Park Commission; directing the Commission to update its scholarship policy to provide for further discounts for recreation programs based on financial need; making certain clarifying changes; and affirming the Planning Department's determination under the California Environmental Quality Act.

Existing Law

The Park Code sets fees for various recreation programs offered by the Recreation and Park Department.

Amendments to Current Law

The proposed ordinance would allow the Recreation and Park Department to set recreation program fees based on the estimated operating costs of those programs. The Department generally could set fees intended to cover the programs' full operating costs, but for programs designated for youth or seniors or persons with disabilities (excluding Camp Mather) the fees could be set to recover no more than 50% of the operating costs. In all other instances, the ordinance urges the Department to set a cost recovery target of not more than 50%, if the program benefits the community at large. All program fees would require approval from the Recreation and Park Commission and once approved would be published on the Department's website.

The ordinance also directs the Recreation and Park Commission to update its scholarship policy to provide for further discounts for recreation programs based on financial need.

Background Information

The current recreation program fees would continue to apply pending the Department setting new fees based on cost recovery under the proposed ordinance.

On June 25, 2025, the ordinance was amended in committee to provide that the Department may seek to recover only 50% rather than 75% of the operating costs of programs designated for youth or seniors or persons with disabilities; and to modify the criteria for which types of households would be eligible for scholarships based on financial need.

RPD disagrees with the proposal to eliminate 7 additional recreation positions

Recreation Staffing Model

- Programs are run with both permanent and part-time staffing.
- If permanent positions are vacant due to hiring delays, RPD uses the salary dollars for part-time employees that run programming.
- Despite vacancies due to attrition and hiring, Recreation's current 253 FTE, is higher than its budgeted 186 FTE by 67 FTE.

Aquatics

- Due to on-going, nationwide Lifeguard shortage, permanent Aquatics positions have been left vacant for an extended period.
- RPD has used TEX positions for a Lifeguard Trainee program

Budget: Partnerships – Policy Recommendation

RPD disagrees with the potential cut of 6 filled Partnerships positions


Elimination of the Partnerships Division would leave the Department with no staff to support and project manage community driven projects and programs. This team supports hundreds of donors and community groups in every supervisorial district.

Examples of current and recently completed projects supported by partnerships include **India Basin, Crocker Amazon Playing Fields, Herz Playground Rec Center, Esprit Park, Gilman Playground, Heron's Head, Francisco Park, McLaren Park Tennis Courts, Embarcadero Plaza, Jackson Park, Koshland Park, Reforestation of Parks in the Southeast of San Francisco, Tenderloin Rec Center Playground, and more.**

Over the last five years the partnerships division has generated on average \$29M a year in philanthropic support and state and federal grants unrelated to the former San Francisco Parks Alliance.



Utility Cost Recovery Surcharge



RPD’s total utility budget is expected to increase by **roughly 50% over the next two years.**

- \$13M in FY 2024-25 to \$20M in FY 2026-27

Court Reservations

Recreation Scholarships and Cost Recovery

Current Recreation Cost Recovery: \$0.15 for every \$1 spent.

Proposal allows Recreation to recover up to specified amounts based on the type of program and the participants. Model is a best practice in other Bay Area cities, (San Jose, Santa Clara, Mountain View, Milpitas) and around the country.

Cost recovery models provide equitable distributions of funding support, greater transparency on the cost of programming, and improved financial sustainability.

Program categories

- **Community benefit** are group-based, inclusive, and promote community health and/or engagement
- **Individual benefit** are more specialized, skill-focused, or serve a single participant, justifying a higher recovery target.

RPD offers over 3,500 classes annually, with fees ranging from \$0 to \$600 and most benefit the community.

Golf

Original proposal

Eliminate \$7.5M General Fund subsidy in FY 2026-27 through the potential leasing of golf courses to private operators.

With approval of trailing budget legislation, and revised golf fees, (pending introduction), RPD will no longer pursue lower cost private sector maintenance agreements.

This solution (a new Utility Cost Recovery Surcharge and revised Golf Fees) will preserve excellent public sector work, generate an additional \$4M over the next two years, and result in up to a 60% reduction of the General Fund subsidy.

- **No fee increases** at Lincoln or Golden Gate (except for utility surcharge)

SWIMMING POOLS (\$0.5M; 4 full-time and 4 part-time positions)

- **Closing one pool out of 9 pools (8 year-round) at a time on a rotating schedule** to reduce costs while keeping overall access available across the city.
 - Swim lessons serve about 5,000 children annually, but waitlists have soared to nearly 7,000—a 131% unmet demand.

RECREATION CENTER PROGRAMS (\$0.5M; 18 part-time positions)

- **Reduced hours at 25 recreation centers** from 60 to 40 per week, a 30% reduction. Fewer senior, tot, and drop-in program hours.

SUMMER CAMPS (\$0.9M; 70 part-time positions)


- A **25% reduction** in summer camps—**2,500 fewer camp slots**
 - In 2024, our summer camps are offering 9,000 spots, but more than 4,200 children are still on the waitlist. One of our most popular, the Jr. Warriors basketball league has more kids waiting to join than are enrolled.

PARK MAINTENANCE (\$2.0M, 21 full-time positions)

- **Reducing 2.5 hours from 120 restrooms** from 8 AM–8 PM to 8 AM–5:30 PM results in a **21% reduction** in open restroom hours.
- **Reduction in Local 261 gardener apprenticeship program**; currently, we have a class of 15, which will be reduced to 6.
- **Reduction in trash service**

PUBLIC SAFETY (\$1.1M, 9 full-time positions)

- A **10+% cut to Park Rangers**—reducing our ability to prevent illegal encampments and possibly eliminating fixed posts like UN Plaza and Dolores Park.



However storing one's private car in a public park is not a public good. Cars are large and space in parks is limited. Cars create health, safety, and environmental liabilities for other users of public space. Charging for parking is both fair and effective. It recovers some of the public cost of providing and maintaining automobile infrastructure, reduces conflicts over limited space, and encourages people to choose sustainable transportation alternatives more often. We have been urging SFMTA, which has chosen to cut essential transit and sustainable mobility while refusing to consider greater cost recovery for private car storage, to follow Recreation and Parks's equitable and sustainable approach. Greater cost-recovery for golf courses is also fair - golf courses require enormous amounts of public space, water, chemicals, and maintenance and serve relatively few users.

San Francisco's park system is excellent – something we should all be proud of, and a model for how we should deliver other public services. It is made possible by the diligence of Recreation and Parks staff, and R&P staffing should not be cut. Thousands of San Franciscans contribute their time and their money to caring for and improving parks and natural areas. Stewardship of public places is good for us individually - it gets us outdoors moving our bodies. It builds community. It is good for the city as a whole, including the native plants and animals we share this place with. Community stewardship of public places is far more effective with city support, including staff support (gardeners, natural resource specialists, and the community garden program, etc), design, planning, and administrative support from professional staff, and grants which can be matched with donations, philanthropy, and volunteer labor and expertise. Community stewardship has taken a hit in the last year from corruption in the Community Challenge Grant program and the collapse of San Francisco Parks Alliance. 
