2 Program]

3 **Resolution authorizing the Director of Public Works to execute amendment to a design**  
4 **agreement for the Laguna Honda Hospital Replacement Program from \$39,155,175 to**  
5 **\$44,633,529.**

7 WHEREAS, The Director of Public Works has entered into an agreement dated  
8 November 30, 2000 with Anshen+Allen/Gordon H. Chong & Partners, A Joint Venture for the  
9 design of the Laguna Honda Hospital Replacement Program in an amount of not to exceed  
10 \$2,400,352; and,

11 WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of  
12 ten million dollars or amendments to said agreements in excess of \$500,000 be approved by  
13 the Board of Supervisors; and,

14 WHEREAS, Resolutions 994-01, 579-03, 561-04, 667-05 and 57-07, the Board of  
15 Supervisors authorized the Director to enter into amendments to the agreement which when  
16 amended would not exceed \$39,155,175; and,

17 WHEREAS, Gordon H. Chong & Partners is in the process of assigning its rights and  
18 obligations under the design agreement to Stantec Architecture; and,

19 WHEREAS, the Director intends to increase the scope of services under said  
20 agreement to extend construction administration services, augment architectural staff, and  
21 provide redesign services and to increase the sum under said agreement to \$44,633,529;  
22 now, therefore, be it


23 RESOLVED, That the Board of Supervisors does hereby authorize the Director of  
24 Public Works to enter into amendments to the November 30, 2000 agreement with

2 Joint Venture, resulting in a contract amount not to exceed \$44,633,529.
