12 establishment of a ten year capital program and in securing voter
13 approval for \$304 million dollars to support the program; and

14 WHEREAS, Anson Moran has been an avid defender of the City's
15 water rights, demonstrated by important settlement agreements on the
16 Tuolumne and San Joaquin Rivers; and

17 WHEREAS, Anson Moran has overseen the development of significant
18 investments in water quality and protection, monitoring and
19 operations; and

20 WHEREAS, Anson Moran has been a distinguished representative of
21 the Public Utilities Commission, dedicating much of his life to
22 serving the people and community of San Francisco; now therefore, be




