16 publication of outreach advertising as determined by the Clerk of
17 the Board of Supervisors in accordance with Section 2.80-1(d) of
18 the San Francisco Administrative Code; and be it

19 FURTHER RESOLVED, that the Chinese Times, a newspaper which
20 circulates primarily in the Chinese community of San Francisco
21 and which is printed in San Francisco on one or more days in a
22 calendar week, is hereby designated as the outreach newspaper of
23 the City and County of San Francisco for the Chinese community,
24 commencing July 1, 2000, for the publication of outreach
25 advertising as determined by the Clerk of the Board of

1 Supervisors in accordance with Section 2.80-1(d) of the San
2 Francisco Administrative Code; and be it

3 FURTHER RESOLVED, that the El Reportero, a newspaper which
4 circulates primarily in the Hispanic community of San Francisco
5 and which is printed in San Francisco on one or more days in a
6 calendar week, is hereby designated as the outreach newspaper of
7 the City and County of San Francisco for the Hispanic community,
8 commencing July 1, 2000, for the publication of outreach
9 advertising as determined by the Clerk of the Board of
10 Supervisors in accordance with Section 2.80-1(d) of the San
11 Francisco Administrative Code.




