1 [Accept and Expend Grant - Retroactive - Federal Emergency Management Agency - Self-
2 Contained Breathing Apparatus Units - \$2,755,882.03]

3 **Resolution retroactively authorizing the Fire Department to accept and expend a grant**
4 **in the amount of \$2,755,882.03 from the Federal Emergency Management Agency to**
5 **purchase Self-Contained Breathing Apparatus Units for the performance period of**
6 **September 26, 2024, through September 25, 2026, and waiving indirect costs.**

7
8 WHEREAS, The Fire Department (SFFD) responds to over 150,000 incidents each
9 year, including fires, vehicle accidents, and medical and other emergencies; and

10 WHEREAS, Due to San Francisco's geographic and topographic layout, as well as
11 other factors, the SFFD is confronted with unique challenges in responding to these incidents;
12 and

13 WHEREAS, The SFFD applied for and was awarded a Fiscal Year 2023 Assistance to
14 Firefighters Grant (AFG) from Federal Emergency Management Agency (FEMA) in the
15 amount of \$2,755,882.03 for new Self-Contained Breathing Apparatus (SCBA) units designed
16 to protect firefighters from serious injuries or illness resulting from inhaling smoke and being in
17 contact with fire, Chemical, Biological, Radiological, Nuclear, and Explosives (CBRNE)
18 hazards and more; and

19 WHEREAS, The use of these grant funds will allow the SFFD to procure new compliant
20 SCBA equipment to replace existing SCBA units that are outdated, and thereby strengthening
21 the SFFD's ability to ensure the safety and health of its members; and

22 WHEREAS, The FEMA grant requires SFFD to purchase the equipment by
23 September 25, 2026; and

24 WHEREAS, The Fire Commission recommended approval of this grant at its meeting
25 on December 11, 2024; and

1 WHEREAS, The grant does not require an ASO amendment; and

2 WHEREAS, The grant requires the City to supply matching funds worth 10 percent of
3 the total award, or \$275,588.21; and

4 WHERAS, The SFFD will provide matching funds worth 10 percent of the total award,
5 or \$275,588.21; and

6 WHEREAS, The SFFD proposes to maximize the use of the grant funds on program
7 expenditures by not including indirect costs in the grant budget; now, therefore, be it

8 RESOLVED, That the Board of Supervisors retroactively authorizes the SFFD to
9 accept and expend grant funds in the amount of \$2,755,882.03 from FEMA for the purpose of
10 purchasing new personal protective equipment; and, be it

11 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
12 indirect costs in the grant budget; and, be it

13 FURTHER RESOLVED, That the Chief of the SFFD is hereby authorized and
14 empowered to execute, deliver, and perform, in the name of the City and County of San
15 Francisco, all applications, contracts, agreements, amendments, and payment requests
16 necessary for the purpose to secure the FEMA grant funds and implement and carry out the
17 purposes specified in the applicable grant application; and, be it

18 FURTHER RESOLVED, That within thirty (30) days of the agreement being fully
19 executed by all parties, SFFD shall provide the final grant agreement to the Clerk of the Board
20 for inclusion into the official file.

The City and County of San Francisco and its Fire Department protect collectively almost 500 National, State and City Designated Historical Landmarks and over a thousand critical infrastructures to include but not limited to major sports arenas, reservoirs, water treatment facilities, under bay fuel transmission lines, power and energy grids,129 schools, 27 colleges/universities, 14 hospitals, research institutions, and financial organizations including a Federal Reserve Bank. The city owns and operates several vital airports, recreation areas, police and fire facilities, and water and power stations located outside county limits. San Francisco, a natural peninsula surrounded by water on three sides, has two major bridges, the San Francisco-Oakland Bay Bridge, and the Golden Gate Bridge. Pre-pandemic, the City had historical daily commuter rates of roughly 456,000 vehicles and heavy public transportation ridership, contributing to the City's daily population numbers of over one and a half million people on any given day. "Few cities have been more impacted by work-from-home than San Francisco. The loss of downtown commuters severely impacted Muni transit ridership and our finances," said SFMTA Director of Transportation Jeffrey Tumlin (2024). However, post-pandemic commuter numbers and locally originating commercial truck, maritime, and air transportation systems are approaching pre-pandemic operations and passenger rates in 2024. The Port of San Francisco oversees a cruise ship terminal, hosts over 100 cruise ship calls and 400,000 passengers annually. The City's 47.355 square mileage is geographically circuitous and distinctively susceptible to fire with a recorded 414,581 housing units (2022 Census), a growing downtown with 482 high rise buildings and about 48,000 Victorian Era homes built primarily of wood some hundred and fifty years ago, upon steep hills with narrow streets speckled throughout many neighborhoods. Zero lot lines leave much of the City's neighborhoods vulnerable to a fast-moving fire incident. Additionally, the City safeguards and responds to incidents within the Golden Gate National Recreation Area, Treasure/Yerba Buena Island, Angel Island, and the San Francisco International Airport. Furthermore, the City's location makes it subject to the effects of weather and seismic related incidents such as earthquakes, tsunami, strong sea winds, annual storms that have combined with years of consistent drought, and the increased heating effects of climate change. These impacts have contributed to recent power outages, road and bridge hazards, and urban and wildland fires. San Francisco is one of the top seven Tier1 Urban Area Ranking cities by the U.S. Department of Homeland Security, meaning if any critical infrastructure were damaged or destroyed within the San Francisco city limits, it would inflict catastrophic consequences on the city and regional populations.

Describe your financial need and how consistent it is with the intent of the AFG Program. Financial losses associated with the 2020-2023-COVID pandemic have been severe and immediate across the City and County of San Francisco with the San Francisco Fire Department (SFFD) forced to rely on Federal relief funds to maintain many day-to-day operations to include essential equipment, supplies, training, and staffing. Financial recovery from the pandemic over the last four years has been slow, and City and regional leaders have acknowledged a high level of uncertainty in regaining adequate business and other city and county tax revenues to meet rising expenditures over the next five to ten years. As the City kicked off its current budget process back in January of 2024, San Francisco is looking at projected deficits over the next two fiscal years of approximately \$244.7 million in FY24-25 and \$554.5 million in FY25-26, totaling almost \$800 million dollars, with deficits increasing in subsequent years to \$1.35 billion annually. Consequently, the City and County of San Francisco has requested that the department identify on-going reductions to general fund support equal to 10% in each year, with an additional 5% contingency request to reduce city department/agency reliance on city general funds (city and county tax and revenue generated funds) to address the current fiscal year deficit. This is in addition to mid-year budget reductions requested of Departments during the current fiscal year. The SFFD relies heavily on the City's general fund for support, and as such is feeling the crunch to assist in economic solutions. With minimum staffing requirements and limited fiscal flexibility in its budget structure, items such as equipment are generally the first to be sacrificed to solve budget deficits. Given these fiscal realities, the SFFD is not anticipating being able to fund the replacement of critical self-contained breathing apparatus (SCBAs) without supplemental funding. There is more and more competition for City General Fund dollars amongst all Departments, and there is less and less of a pool of those dollars available overall due to the negative economic impact of COVID on City revenues. Given the scale and scope of the budget deficit currently facing the City, such drastic budget cuts as staffing reductions and brownouts have been discussed, which the SFFD will be looking to avoid during this difficult upcoming budget process. Departmental budget reductions are only part of the City's solution plan, as the Mayor's office continues to offer several other strategies to balancing the budget. Committees have been constructed within the SFFD to ensure consistent financial planning strategies (to include the acquisition of grants, partner collaboratives and other revenue streams and resources) are identified and implemented to support the SFFD's priorities to improve public health and safety, building and street safety, reduce homelessness and improve emergency medical and mental health delivery services, and ensure accountability and equity in service delivery. With our current budget constraints, this non-salary initiative to replace outdated SCBA's will be nearly impossible to implement using general fund allocations. Therefore, the SFFD has strategically worked to diversify and increase funding streams to support the acquisition of vital equipment such as SCBA's ensuring that the SFFD keeps its members safe and in service, despite any shortfalls to the city and county general funds. While we are making some gradual process in our attempts to increase grant revenue streams, the needs of the SFFD remain urgent and underfunded. Funding from the FEMA 2023 AFG program protects our members and community now and in the future.

The Department has faced an annual increase in total call volume over the past decade with a noted overall 10% increase in incidents over the last three years to include medical emergency, traffic accident, substance overdose, mental health crisis, and violent incident related calls. The San Francisco Department of Public Health has recorded 806 overdose deaths in 2023, up from 647 in 2022, with fentanyl indicated in most cases. The San Francisco Fire Department's Community Paramedicine Response Teams are working with multiple City agencies and community-based organizations throughout the city to reduce and prevent further deaths. Our Community Paramedicine Response Teams responded to 7,995 calls for rescue and emergency medical services, and their scope of responsibility (as well as call volume numbers) continue to grow. The Department is invested in the collaborative multi-agency strategies to prevent overdose deaths as we continue to respond to the needs of the City's most vulnerable and underserved communities to include, but not limited to, those experiencing homelessness, mental health crisis, health disparities associated with substance use, abuse, and overdose. Subsequently, the City faced a profound increase in "street fires" during the pandemic years. The SFFD's frontline firefighters, Fire Marshal, and Fire Prevention and Safety division, quickly responded by initiating collaborative initiatives with our community paramedicine units to disseminate fire safety information, training and supports in multiple languages, formats, and venues to affected residents, neighborhoods, and partner agencies to reduce fire and safety incidents caused by unhoused/transient individuals and communities throughout the city. Given the density of buildings in San Francisco, these fires have the potential to take out multiple structures if not put out quickly. Additionally, countless studies highlight the impact and effects of global warming to regional climate, with estimations of extreme weather phenomenon's, wildland fires, flooding, viral outbreaks/pandemic and other natural disaster incidents and catastrophic events in the coming years. The San Francisco Fire Department (SFFD) expects to see a continued increase in San Francisco based rescue call volume and regional mutual aid assistance requests in review of internal call volume data analysis and external climate change studies over the last 10 years. This analysis clearly predicts a near future in which SFFD first responders must be ready and equipped to respond to the magnitude of calls from residents experiencing continued communicable disease outbreaks, surges in health disparities particularly in low-income, elderly, and racially marginalized communities, increases in mental health distress and substance abuse across all socio-economic communities. The Department, in anticipation of these events, continues to work strategically with the City's Department of Emergency Management and Department of Public Health to develop coordinated disaster response plans. The SFFD's Neighborhood Emergency Response Team (NERT) division has bolstered its efforts to educate and train resident volunteers to acquire the skills, knowledge, and confidence needed to be ready and equipped to safely mobilize themselves and assist neighbors as possible should the effects of any number of catastrophic events hinder emergency response times. These multi-agency and community collaboration initiatives are just a few examples of the many steps the City and County of San Francisco has initiated to reduce the risk of resident injury and fatalities and strengthen rescue and recovery efforts during catastrophic events the city and region are expected to face throughout the next decade.

Please describe your organization and/or community that you serve.	2020 census data indicates the City and County of San Francisco ranked as the 17th most populated and 2nd most densely populated city in the nation, with the 2022 US Census estimating a total estimated residential county population of 808,437, increasing dramatically on any given day with the influx of commuters and tourists, despite current work from home trends. According to the most recently reported US Census Bureau estimates, San Francisco County's population's racial demographic makeup was 50.8% White, 37.3% Asian, 7.7% Unknown Race, 5.7% Black/African American, 4.9% from two or more races, 0.8% Native Hawaiian-Pacific Islander, 0.5% Native American/Alaskan Native. Additionally, census data further illustrates the cultural and ethnic diversity within the city with 15.9% of the population identified as Latinx (regardless of race) and an estimated 163 languages spoken at home by residents. Meanwhile, the city's 47.355 square mileage is geographically circuitous, and the city's topography is difficult to maneuver with old and narrow streets and over 50 hills from 100 to 927 feet within its city limits. San Francisco's infrastructure is distinctively susceptible to fire with approximately 400,000 housing units, 48,000 historic wood houses, and a growing downtown with 72 high-rises and 26 skyscrapers. The State of California has certified the city and county of San Francisco's new housing plan, which calls for the creation of over 82,000 homes – more than tripling the City's decades-long annual housing production average. Recognizing the City's current, unique and forthcoming fire suppression and emergency medical service needs, the SFFD has in its ranks a combined force of 1,719 Firefighting and Emergency Medical Personnel with a daily staffed fleet of 44 Engines, 20 Trucks, and approximately 50 ambulances, divided into two Divisions, with ten Battalion Districts and 44 stations located throughout the city, and fortified with specialty units including: 2 Heavy Rescue Squads, 2 Coastal Rescue units (Cliff & Surf), 1Rescue Boat, 2 Rescue Water Craft, 3 Fireboats, a Mobile Command Vehicle, 2 Multi-Casualty Units, a Hazardous Materials Unit, a CO2 unit, and a Mobile Air Unit. The SFFD responded to 175,124 calls for service last calendar year, and provided the public with: 1) Emergency Medical Services, Fire Suppression, Community Paramedicine and specialized unit deployment in times of high level safety and health threats, 2) Fire Prevention code enforcement, investigation and inspection programs minimizing loss of life and property, 3) emergency planning and community disaster response coordination, to ensure the protection of thousands of lives should a large-scale disaster occur, and 4) community outreach to promote community health and fire safety. In the last three years, the SFFD and its community of residents, citizens, and visitors faced the unprecedented challenges of the pandemic health crisis, regional wildfires, and multiple 4 and 5 alarm infrastructure fires. Despite these challenges and their test to the fortitude of various City infrastructure and the Departments aging equipment, the men and women who serve through the SFFD are unfailingly ready to respond to any type of crisis at any time. Chief Jeanine Nicholson, the 26th Fire Chief of San Francisco continues to strategically lead a strong team focused on strengthening the SFFD's service model while increasing the Departments fiscal capacity to acquire and utilize the critical tools needed to effectively protect the property and lives of its members and the people of San Francisco and surrounding communities.

Narrative	
Project Description	The San Francisco Fire Department (SFFD) faces unprecedented challenges providing services during the COVID pandemic and corresponding fiscal crisis. The City's population volume and magnitude of critical facilities and infrastructure at-risk to the destructive effects of natural disasters and/or human-caused hazards clarify the City and County of San Francisco's high priority need for supporting the SFFD's greatest asset of skilled personnel. One of the key components to effectively utilizing highly trained personnel during disasters is providing an current and compliant Personal Protective Equipment (PPE) inventory in the form of self-contained breathing apparatus (SCBA) units, comprised of four parts: regulator, cylinders, back plate and harness, and face piece. Currently, 411 pieces of the departments inventory of SCBAs assigned to seated positions need to be replaced, as they are expired and/or out of compliance to meet current National Fire Protection Association (NFPA) and internal standards. When the new version of the NFPA standards is released later this year, the SFFD's SCBA inventory will be over 16 years old and three NFPA safety versions behind the upcoming standard. The SFFD recently conducted an internal personnel safety risk assessment and developed objectives that clarify the priority need to safeguard first responders from exposure to harmful toxins and carcinogens that exist in the firefighting environment because of the nature of the job that can lead to various cancers, life threatening burns, and lung and heart disease. This recent assessment identified that our current inventory accommodates at least one SCBA unit for each seated position on our apparatus, and 95% of units meets NFPA Standards 1981 (2007 Version) and will be even further out of compliance with the new upcoming consolidated draft NFPA 1970 standards. Many of our cylinders are nearing the end of their life cycle in 2027. Additionally, this assessment outlined some other challenges, in that our current SCBA inventory includes units from different models, which means the SCBA units provided to members by our Division of Training and/or placed on active fire suppression rigs meet differing standards and/or are on different maintenance, repair, and cleaning schedules. SCBA units are critical to ensuring firefighter safety during a fire incident and to protect member health over the long term. In recent years, the SFFD's Health, Wellness and Safety division has increased focus trying to reduce firefighter exposure to carcinogens that often lead to acute and chronic respiratory illnesses, acute pulmonary conditions, and multiple forms of life-threatening cancer. The SFFD maintains a collaborative partnership with the San Francisco Firefighters Cancer Prevention foundation on various initiatives for reducing

carcinogenic exposure, which has resulted in a comprehensive testing and review process for new SCBA units. Additionally, the SFFD has implemented several new policies and procedures to try and improve the health and safety of members when it comes to SCBA units and other personal protection equipment. While the SFFD has implemented multiple fundraising strategies to diversify its revenue streams, it has been unable to secure a funding award large enough to make these necessary safety measures. The SFFD is requesting a 2023 FEMA AFG project award of \$3,031,470.24 to purchase 411 new replacement PPE- SCBA units, remove outdated units from circulation, protect the health and safety of first responders, and decrease member exposure to elements that could cause them harm, injury, or death.

The City's economy and general fund (tax-based revenue) have been overwhelming impacted by ongoing COVID recovery challenges, critical infrastructure maintenance and protection costs, rising personnel costs and decreased tax revenue due to reductions in tax-based revenue. The SFFD relies heavily on the City's general fund to make up its operating budget, and due to these challenges, funding requests to the City for increases to non-personnel items, such as PPE, are challenging. The SFFD has been unable to secure sufficient funds to cover important safety equipment needs, even pre-pandemic. The SFFD must aggressively seek alternative funding sources to fund crucial equipment. Presently, a 2023 AFG award appears to be our only viable option to fund the replacement of aged, in operable and out of compliance SCBA units to ensure the continued safety of members during field operations. The SFFD is committed to meeting compliance standards of NFPA 1852's established requirements for SCBA units. Currently, a collective total of 411 pieces of the SFFD's SCBA inventory need to be replaced to protect firefighter health and meet industry standards and safety compliance guidelines. These units exceed the age of 15 years and multiple NFPA determined expiration cycles (NFPA 1981-2019 Edition, NFPA 1852-2019 Edition). The SFFD is seeking a total award of \$3,031,470.24; for the cost of 411 SCBA units at \$7,375.84 after tax per unit to replace old SCBA units now past multiple NFPA and other applicable safety standards. The multiple catastrophic events over the last three years (pandemic, regional wildfires, civil unrest) have increased operational challenges and exasperated funding, leaving very limited funding options and resources available to assist with replacing out-of-compliance PPE such as SCBA units. A recent increase in hiring coming out of the pandemic, to backfill depleted staffing levels during COVID, has forced the SFFD to spend most of its budgeted PPE funding on PPE for recent new hires. The SFFD's Bureau of Equipment and Division of Training maintains the servicing of SCBAs with cleaning, repair, and training, which is a cost savings for the department. However, current inventory is made up of multiple SCBA models that often require different replacement parts to service, and due to the age of the majority of the SCBA units in circulation and ongoing supply chain delays, these parts can be costly and hard to locate. In addition to fiscal and operational benefits, replacing old SCBA units will enable the department to take advantage of any new respiratory based personal protection equipment technology, such as updated and more reliant member locator and tracking capabilities, improving firefighter team coordination, response and retreat timing, and maintaining best safety practices. Additionally, by purchasing new SCBA units, the SFFD would acquire new units that have incorporated improvements in material resilience for added protection, weight and form for increased agility, ease of cleaning and savings on repair costs. These improved ergonomic factors allow firefighters to incur less of a physical toll on their bodies wearing this protective equipment. An investment to replace many of these units would reduce costs and potential liability from toxic exposure should something happen at an incident. In recent years, the SFFD has seen the costs related to cancer diagnosis increase, both in terms of providing care for members that have been diagnosed but also with the cost of human life of active and retired members. The SFFD, in collaboration with the SF Firefighters Cancer Prevention foundation, has undergone large initiatives to minimize exposure to cancer-causing agents as well as provide means for early detection. Awarded funds in the amount of \$3,031,470.24 would allow the SFFD to continue the push for collaborative health initiatives to protect and save member lives.

The SFFD developed this high priority request to communicate the need for critical personal protection equipment (PPE) to ensure the health, safety and well-being of San Francisco's firefighters and emergency response personnel. SCBAs are one of the most crucial pieces of PPE a firefighter has available to provide the greatest amount of airway protection in the fireground environment. In densely populated and developed urban settings, most recorded fire incidents are in homes and businesses and see the destruction of inorganic/synthetic building materials, furniture, clothes, and electronics, which give off high toxicity fumes. The International Association of Fire Fighters (IAFF) and Metropolitan Fire Chiefs Association (Metro Chiefs) in a 2022 statement recommended all outdated/expired SCBA units should be replaced as possible to reduce exposure to toxins, chemicals and carcinogens that may increase cancer and other health disparities. They encourage members to reduce their exposure to Polyfluoroalkyl Substances (PFAS) chemicals, which have been linked to cancer – the leading cause of fire fighter deaths - by wearing all available PPE to include SCBA units during firefighting, overhaul, and working in smoke, as the best first line of defense to protect from fireground contaminants. Therefore, the SFFD is proposing to make use of an award to outfit members with these new SCBA units, which will serve as their primary respiratory protection against toxic smoke fumes, high heat, toxic chemicals and carcinogens that can occur in a variety of incidents. The SFFD, due to historical financial challenges and constraints, compounded by the pandemic's catastrophic fiscal impact on the State, City and County's tax-based revenue streams, has been unable to address critical SCBA unit replacement due to a lack of funds. As a result, the SFFD is requesting Federal assistance to replace outdated SCBA units with current units offering the latest advancements in protective materials that offer greater resistance to chemical exposure and less water absorption, help to minimize contamination, provide improved durability to withstand the rigors of the fireground, and improve SCBA ergonomics to help reduce user fatigue. Additionally, new face pieces offer enhanced performance with lower breathing resistance that help to reduce user burden and supports wireless connectivity between devices for improved configurability, data transmission/retrieval, firefighter safety, and fireground accountability. Lastly, improved communication between the firefighter and incident command increases critical fireground accountability and communications, and comprehensive alerts can notify SCBA wearer and incident command of impending electronics degradation and health risks due to elevated temperatures and toxins to meet current and upcoming NFPA requirements and improve operational efficiencies. Furthermore, new SCBA units increase the SFFD's ability to provide mutual aid during local and regionally based catastrophic events in alignment with the City and County of San Francisco's FEMA approved and recently updated Hazard Mitigation Plan. The SFFD consistently assess strengths, challenges, and fiscal barriers to providing services and actively continues to develop a list of potential mitigation strategies to prepare and provide the responsive emergency and safety net services San Francisco residents and regional partners rely. It is crucial that the City and County of San Francisco and its Fire Department can provide first responders with more advance personal protective clothing and equipment designed to meet the demands of modern firefighting and the changing climate. The acquisition of new SCBA units required to meet previously noted NFPA standards provides a baseline or a minimum level of safety for all SFFD first responders. The SFFD would like to thank the Peer Review Committee for their time and consideration of this application and request.

WHEREAS, The San Francisco Fire Department (SFFD) responds to over 150,000 incidents each year, including fires, vehicle accidents, and medical and other emergencies; and,

WHEREAS, Due to San Francisco's geographic and topographic layout, as well as other factors, the SFFD is confronted with unique challenges in responding to these incidents; and

WHEREAS, The SFFD applied for and was awarded a Fiscal Year 2023 Assistance to Firefighters Grant (AFG) from the Federal Emergency Management Agency (FEMA) in the amount of \$2,755,882.03 in federal funding for Personal Protection Equipment; and,

WHEREAS, The use of these grant funds will allow the Department to procure new compliant Personal Protection Equipment of self-contained breathing apparatus (SCBA) units, designed to protect firefighters from serious injuries or illness resulting from inhaling and or contact with fire, Chemical, Biological, Radiological, Nuclear, and Explosives (CBRNE) hazards and more; and

WHEREAS, The grant requires the City to supply matching funds worth 10 percent of the total award, or \$275,588.21; and,

WHEREAS, The SFFD wishes to retroactively accept and expend the grant, to support and promote strengthening the Department's ability to ensure the safety and health of its members; now, therefore, be it

RESOLVED, That the Fire Commission recommends that the Board of Supervisors authorize the Fire Department to retroactively accept and expend AFG funding from FEMA in the amount of \$2,755,882.03 in federal funding to

purchase SCBA units to support the Department's fire suppression response capabilities and increase member safety and the protection of member health.
