3 **Resolution authorizing the General Manager of the San Francisco Public Utilities**  
4 **Commission to accept a gift of snowflake lights valued at \$134,757 from the Market**  
5 **Street Association for use for the annual Market Street snowflake lights program.**

7 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) has partnered  
8 with the Market Street Association since 2008 to implement the Market Street snowflake lights  
9 program during the winter holiday season; and

10 WHEREAS, The Market Street snowflake lights program consists of 276 snowflake  
11 lights that are installed on Market Street from Main Street to Ninth Street; and

12 WHEREAS, The Market Street Association owns the snowflake lights, while the  
13 SFPUC installs them and supplies the energy needed for the lights to illuminate; and

14 WHEREAS, The Market Street Association has offered to donate the snowflake lights  
15 valued at \$134,757 to the SFPUC; and

16 WHEREAS, The SFPUC has the facilities needed to store the lights; and

17 WHEREAS, The SFPUC has the resources needed to continue to implement the  
18 Market Street snowflake lights program; now, therefore, be it

19 RESOLVED, That the Board of Supervisors approves the gift and authorizes the  
20 General Manager of the SFPUC to accept the snowflake lights donation from the Market  
21 Street Association, valued at \$134,757.


