## FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING BETWEEN CERTNA AND CITY AND COUNTY OF SAN FRANCISCO ASSESSOR-RECORDER FOR AB 578 ELECTRONIC RECORDATION IMPLEMENTATION

THIS FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING (hereinafter, this "Amendment") is made and executed as of this th day of August, 2018, by and between the California Electronic Recording Transaction Network Authority, a Joint Powers Authority, hereinafter referred to as "CONTRACTOR", and City and County of San Francisco, a municipal corporation, hereinafter referred to as "COUNTY", acting by and through its Assessor-Recorder.

## **RECITALS**

WHEREAS, CONTRACTOR and COUNTY have entered into that certain Memorandum of Understanding for AB 578 Electronic Recordation Implementation, dated as of January 18, 2017; and

WHEREAS, Article II, Section C of the MOU provides that the MOU shall take effect as of January 11, 2016 and shall continue in full force and effect for three years thereafter unless otherwise terminated as provided in the MOU. COUNTY and CONTRACTOR may extend the term of the MOU pursuant to an executed amendment.

WHEREAS, CONTRACTOR and COUNTY desire to extend the term of the MOU by an additional three years.

## **AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CONTRACTOR and COUNTY hereby agree as follows:

- I. Article II.B of the MOU is hereby amended to read as follows:
- "B. Term of the MOU. This MOU shall take effect as of January 11, 2016 and shall continue in full force and effect for six years thereafter to January 10, 2022, unless otherwise terminated as provided in this MOU. COUNTY and CERTNA may extend the term of this MOU pursuant to an executed amendment."
- II. Except as amended hereby, all other terms and conditions of the MOU shall remain in full force and effect.
