

Children know about Civil Rights leaders such as Dr. Martin Luther King, Jr. and Cesar Chavez. But many have yet to learn about the transformational work of Ed Roberts, hailed as the "Father of Disability Rights." *Ed Roberts: Father of Disability Rights* is a biography about Edward Verne Roberts, who, at age 14, became a quadriplegic as a result of Polio. The life he lived post-Polio was one of transformation, both for himself, and for society's image of people with disabilities. Ed became empowered through his determination, his education, and his advocacy for supports and services that enabled him to become an independent citizen. Ed knew he was not disabled by Polio as much as he was disabled by societal responses to his disability. He fought for his own rights and the rights of all people with disabilities. His legacy continues to inspire equality and respect, both in the United States and abroad.

#### About the Author

Diana Pastora Carson, M.Ed., is an educator, author, disability rights advocate, and a consultant and speaker specializing in inclusion, and diversity as it relates to disability. Ms. Carson's passion for disability and diversity appreciation stems from her brother's experience of growing up being misjudged, excluded, and Disabled. Ms. Carson has taught Disability Studies courses through the San Diego State University Foundation and is also an elementary school teacher. She has served on the Board of Directors of Disability Rights California, and is the author of *Foundations for Ability Awareness*, and *Ability Awareness in Action: Teaching Ability Awareness to Children and Youth*. Through her writings, trainings, and speaking engagements, Ms. Carson guides both children and adults in exploring the subject of disability, societal attitudes around disability, and the impact of those attitudes. Empowering awareness, inclusion, and total diversity appreciation is her goal.

#### About the Illustrator

Patrick Wm. Connally is an artist, civil rights advocate, co-host and producer of a radio program focused on disability issues, consultant on access and disability rights, and most recently, a family caregiver and in-home support provider. Patrick worked closely with Ed Roberts for years and knew him as a human being with a commitment and passion for creating independence for people with disabilities. Patrick has served extensively on government and non-profit boards and committees such as Disability Rights California, Federal Government's Projects of National Significance, World Institute on Disability, Research and Training Center on Personal Assistance Services. He is the founder and president of Disability Rights Enforcement Education Services. Patrick's artwork has been used to promote world-class museum events and to raise funds for animal rescue projects. It is an expression of his experience of disability as well as other dimensions of his past, passions, and identity.

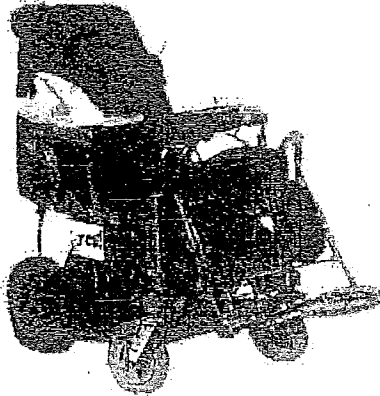

## Ed Roberts's wheelchair, about 1973

Outfitted with the type of seat used in Porsche automobiles and a large headlight for traveling at night, this motorized wheelchair captures the unique personality of a man who dedicated his life to securing rights, freedoms, and improved quality of life for people with disabilities. Ed Roberts, who was paralyzed by polio at a young age, began his activist career in 1962 when he fought for the right to attend the University of California at Berkeley. He went on to help establish the first independent-living centers for disabled people in the United States and traveled the world campaigning for disability rights.

## Ed Roberts Day January 23rd

In its sixth year, Ed Roberts, the creator of Homecare in California, now in all states.

Ed sued UC Berkeley for admission in 1962. He was the class valedictorian. The headline of the day was, "Helpless Cripple Attends Cal". Unemployment was 100% for cripples.

He founded the first Disabled Students Program in the world.

He was the founding Director of CIL, the first Independent Living Center.

Ed got a PhD. (abd), and taught at Cal for 8 years.

He worked for Governor Jerry Brown in Sacramento running the largest organization in the world

He got a MacArthur Genius Grant of \$250,000.00.

He founded the World Institute on Disability.

The US Government identified WID, as the leading authority on PAS and IL.

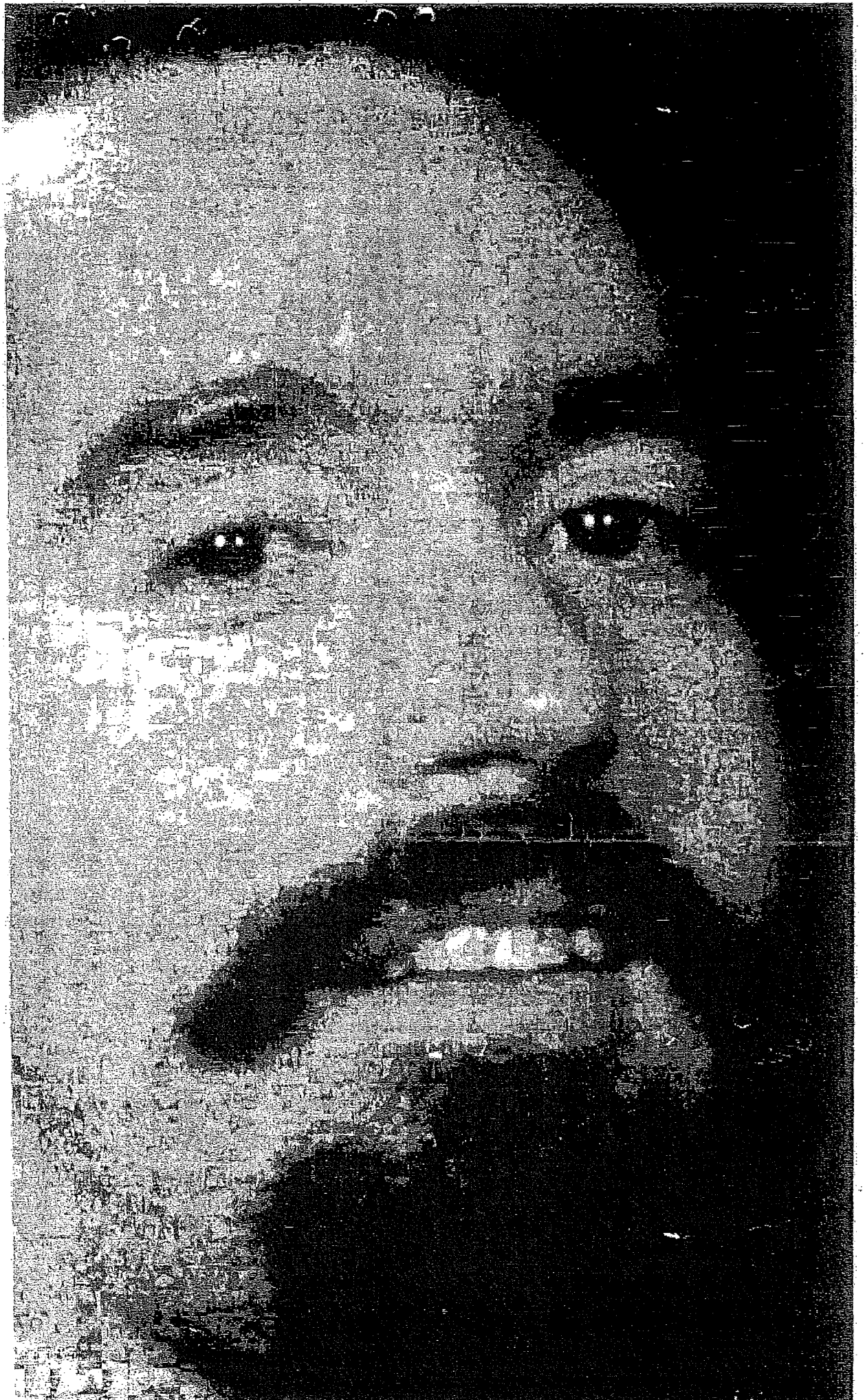
He was inducted into the California Hall of Fame, by Governor Jerry Brown.

January 23rd has been a California State Holiday for over five years.

He created Homecare in the place of a Nursinghome Monopoly, which violates the 1999 US Supreme Court "Olmstead Decision".

Mayor Tom Bates and State Senator, husband and wife, holding each others elected offices, were next door neighbors of Eds. They are being honored for their lifelong political work in disability at Ed Roberts Day, in Berkeley, this year.

Berkeley has the highest per capita of people with disabilities in the world.

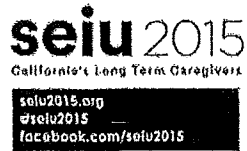

Administrative Code, Chapter 70, and California Welfare and Institutions Code, Section 12301.6 (Ordinance Nos. 185-95; 67-00, 55-05, and 213-08).

**Board Qualifications:**

The governing body of the In-Home Supportive Services (IHSS) Public Authority shall be composed of thirteen (13) members appointed by the Board of Supervisors. The Board of Supervisors shall solicit recommendations for appointment of qualified members through a fair and open process, including reasonable written notice to, and affording reasonable response time from, the IHSS Authority, members of the general public, and other interested persons and organizations. No fewer than 50 percent (50%) of the membership shall be individuals who are current or past users of personal assistance services paid for through public or private funds or who are recipients of IHSS.

Membership categories on the governing body shall be as follows:

1. Two (2) consumers over the age of 55 years, each authorized to represent organizations that advocate for aging people with disabilities;
2. Two (2) consumers between the ages of 18 and 60 years, each authorized to represent organizations that advocate for younger people with disabilities;
3. One (1) consumer at-large over the age of 55 years;
4. One (1) consumer at-large between the ages of 18 and 60 years;
5. One (1) worker who provides personal assistance services to a consumer;
6. One (1) Commissioner from the Human Services Commission, recommended to the Board by the Commission;

7. One (1) Commissioner from the Commission on the Aging, recommended to the Board by the Commission;
8. One (1) Commissioner from the Public Health Commission, recommended to the Board by the Commission;
9. One (1) member of the Mayor's Disability Council, recommended to the Board by the Council;
10. One (1) member representing the bargaining unit of the union that represents IHSS independent providers; and
11. One (1) consumer at-large who is 18 years of age or older.

The IHSS Public Authority shall provide assistance in finding personnel for the IHSS Programs through the establishment of a central registry and related functions, and to perform any other functions, as may be necessary for the operation of the Authority, or related to the delivery of IHSS in San Francisco.

Initial appointments of both the consumer and worker members shall be made from a list of recommendations based on applications designed by, and submitted to, the IHSS Task Force of Planning for Elders in the Central City. The governing body of the Authority may make recommendations to the Board of Supervisors for establishing procedures for consumer and worker member appointments. Every attempt shall be made to assure that each appointee will be able to serve the full term to which he/she has been appointed, in order to ensure continuity in the work of the Authority.

After the terms of the initial period are complete, each appointment to the governing body shall thereafter be for a three-year term. A member may be reappointed, but may not serve more than a total of nine consecutive years on the governing body. The initial appointment periods shall be staggered as follows: Three (3) one-year terms; Four (4) two-year terms; and Four (4) three-year terms. Upon appointment, members shall draw lots to determine the length of each member's initial term.

Qualified applicants must reside in San Francisco and have: familiarity with, or knowledge of, personal assistance services; the capacity to understand their role to aid and assist the Authority in the administration of its duties; and the ability to attend regularly scheduled meetings, which shall occur only in facilities which meet disability access requirements.

Report: The Authority shall submit an annual report to the Board of Supervisors detailing its functions and evaluating its operation for that year. In addition, such report shall present the Authority's specific goals and objectives for the coming year and its plan for meeting those goals and objectives.
