10 6, 2007, and every six months thereafter until the appropriation is fully expended, the Mayor's
11 Office of Housing shall report to the Board of Supervisors on the uses of these funds for down
12 payment assistance loans.

14 Section 4. The total appropriation of \$5,000,000 for down payment assistance is reserved
15 pending review of an expenditure plan by the Board of Supervisors Finance Committee.


