
Dear Ms. Alabanza:

4 **venue liquor license to Bruno's Management LLC, to do business as Bruno's**

7 **Business and Professions Code, Section 23958.4; and requesting that the**  
8 **California Department of Alcoholic Beverage Control impose conditions on the**

11 WHEREAS, Bruno's Management LLC is seeking the issuance of a Type-90 on-  
12 sale general music venue liquor license to Bruno's Management LLC, to do business as  
13 Bruno's located at 2389 Mission Street (District 9); and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of  
17 support with the Department of Alcoholic Beverage Control under California Business  
18 and Professions Code, Section 24013, and recommends that the Department of  
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Except as provided in Condition 2 below, no noise shall be audible beyond  
22 the area under the control of the licensee. (SF district office only); 2) Any noise caused  
23 by entertainment or amplified sound that is subject to the provisions of an active  
24 Entertainment Permit issued by the San Francisco Entertainment Commission shall be  
25 authorized in accordance with the limits established by that Entertainment Permit,

1 including any limitation on hours during which entertainment or amplified sound is  
2 permitted. A violation of the entertainment or amplified sound noise conditions of the  
3 Entertainment Permit, as determined by the San Francisco Entertainment Commission  
4 (or any successor agency), shall be deemed to be a violation of this Condition. Any  
5 noise that is not subject to, or is beyond the scope of, the Entertainment Permit shall be  
6 subject to Condition 1 above. "Entertainment Permit" means any of the following: a Just  
7 Add Music permit, a Limited Live Performance permit, a Place of Entertainment permit,  
8 a Fixed Place Amplified Sound permit, or any similar such permit issued by the San  
9 Francisco Entertainment Commission. (SF district office only); and 3) Petitioner(s) shall  
10 actively monitor the area under their control in an effort to prevent the loitering of  
11 persons on any property adjacent to the licensed premises as depicted on ABC-253;  
12 now, therefore, be it

13           RESOLVED, That in accordance with California Business and Professions Code,  
14 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
15 hereby determines that the issuance of a Type-90 on-sale general music venue liquor  
16 license to Bruno's Management LLC, to do business as Bruno's located at 2389 Mission  
17 Street, will serve the public convenience or necessity of the City and County of San  
18 Francisco; and, be it

19           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
20 San Francisco hereby endorses and adopts the recommendations of the Police  
21 Department listed above and recommends that the Department of Alcoholic Beverage  
22 Control issue the license with those conditions.


