4 **and County of San Francisco for \$85,000; the lawsuit was filed on October 18, 2018, in**
5 **San Francisco Superior Court, Case No. CGC-18-570702; entitled Benito Taylor v. City**
6 **and County of San Francisco; the lawsuit involves alleged personal injury when**
7 **plaintiff tripped and fell over an uncovered utility box on the sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Benito Taylor v. City and County of
12 San Francisco, San Francisco Superior Court, Case No. CGC-18-570702 by the payment
13 of \$85,000. The lawsuit involves alleged personal injury when plaintiff tripped and fell over an
14 uncovered utility box on the sidewalk.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 October 18, 2018, and the following parties were named in the lawsuit: plaintiff: Benito Taylor;
