3 **Ordinance authorizing settlement of the lawsuit filed by Daniel Alvarenga against the**
4 **City and County of San Francisco for \$60,000; the lawsuit was filed on**
5 **February 28, 2020, in United States District Court, Case No. 20-cv-01486 JSW; entitled**
6 **Daniel Alvarenga v. City and County of San Francisco, et al.; the lawsuit involves**
7 **alleged constitutional violation for use of excessive force in making an arrest.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Daniel Alvarenga v. City and County of
12 San Francisco, et al., United States District Court, Case No. 20-cv-01486 JSW by the
13 payment of \$60,000. The lawsuit involves alleged constitutional violation for use of excessive
14 force in making an arrest.

15 Section 2. The above-named action was filed in United States District Court on
16 February 28, 2020, and the following parties were named in the lawsuit: Plaintiff Daniel
17 Alvarenga; Defendants City and County of San Francisco, Tyrone He, Glennon Griffin.
