9 WHEREAS, The California State Assembly, by enacting Assembly Bill 2522 (Shelley)  
10 in the year 2000, created a new one-year Pedestrian Safety Program which made available  
11 \$8 million in State Transportation Funds to the California Department of Transportation  
12 (Caltrans) specifically for pedestrian safety projects; and,

13 WHEREAS, The California Department of Transportation issued a Request for  
14 Proposals, in March 2002, soliciting pedestrian safety project proposals from local and  
15 regional agencies and municipalities throughout the State to be evaluated on competitive  
16 basis; and

18 WHEREAS, The San Francisco Department of Parking and Traffic created the Livable  
19 Streets Program, including the Pedestrian Program in the year 2000, to better serve the  
20 walking public in the City and reduce negative impacts of motor-vehicle traffic on residents  
21 and visitors; and,

23 WHEREAS, The Department of Parking and Traffic is requesting a Pedestrian Safety  
24 Program Grant totaling <sup>397,962</sup>~~\$398,000~~, from the California Pedestrian Safety Grant Program, to


1 implement the Tenderloin and Mission Pedestrian Safety Project in the Northern Mission and  
2 Tenderloin Districts; and,

3 WHEREAS, The California Pedestrian Safety Program does not require local match  
4 funding for proposed projects; now therefore be it


5 RESOLVED, That the Board of Supervisors does hereby authorize the Executive  
6 Director of the Department of Parking and Traffic to apply retroactively, accept, and expend  
7 up to 397,962  
8 up to ~~\$398,000~~ in State Pedestrian Safety Program grant funds for the implementation of the  
9 Mission/Tenderloin Pedestrian Safety Project, and to execute all documents necessary  
10 therefore.


