3 **Resolution authorizing the Department of Parking and Traffic to accept and expend a**
4 **grant in the amount of \$400,000 from the California Department of Transportation**
5 **(Caltrans) to establish a Motorist Information System.**

7 WHEREAS, The Golden Gate Bridge is the primary traffic conduit from the City to
8 Marin County and the North Coast; and,

9 WHEREAS, The proposed Motorist Information System (MIS) will enable the
10 Department of Parking and Traffic (DPT) and Caltrans to provide traffic information along the
11 Doyle Drive approach to the Golden Gate Bridge; and,

12 WHEREAS, DPT proposes to implement the MIS using a combination of
13 extinguishable message signs (EMS) and the California Highway Advisory Radio (HAR) to
14 inform the public of traffic impacts resulting from the Doyle Drive reconstruction project; and,

15 WHEREAS, DPT will design needed elements of the MIS, which include a computer
16 interface and fiber optic connection to the Caltrans Transportation Management Center,
17 located in Oakland; and,


18 WHEREAS, Caltrans will provide \$400,000 from the Surface Transportation Program;
19 now, therefore, be it

20 RESOLVED, That the Board of Supervisors authorizes the Director of Transportation or
21 his designee accept and expend \$400,000 in grant funding from the California Department of
22 Transportation (Caltrans) to establish a Motorist Information System (MIS) which will enable
23 DPT and Caltrans to provide traffic information along the Doyle Drive approach to the Golden
24 Gate Bridge.






