3 **Resolution authorizing the Airport Commission to retroactively accept and expend**
4 **funding in a total amount of \$700,500 from the Transportation Security Administration**
5 **("TSA") for the Airport K-9 Explosives Detection Team Program.**

7 WHEREAS, The Airport utilizes canine (K-9) teams to detect explosives at the Airport;
8 and,

9 WHEREAS, The Airport K-9 Explosives Detection Team Program incurs expenses for
10 handler salaries, handler overtime, handler uniforms (laundry), K-9 food, K-9 veterinary care
11 (medications), K-9 kenneling, vehicles, vehicle care and maintenance, handler training/travel,
12 and explosives training/travel; and

13 WHEREAS, The Airport will be reimbursed by the TSA \$700,500 for the Airport K-9
14 Explosives Detection Team Program expenses incurred at Airport; and

15 WHEREAS, The grant does not require ASO amendment; and

16 WHEREAS, The Airport Commission proposes to maximize use of available grant
17 funds on program expenditures by not including indirect costs in the grant budget; and


18 WHEREAS, The Airport Commission approved the acceptance and expenditures of the
19 TSA K-9 Explosives Detection Team Program funds pursuant to Resolution No. 09-0143
20 dated June 2, 2009; now, therefore, be it

21 **RESOLVED**, That this Board of Supervisors hereby authorizes the Airport to
22 retroactively accept and expend the TSA funding for the Airport K-9 Explosives Detection
23 Team Program; and be it

24 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives the inclusion of
25 indirect costs in the grant budget.


