7 WHEREAS, Elsie Tonelli was a longtime leader in the City and County of San
8 Francisco and the Excelsior District, and is a person worthy of recognition for her
9 accomplishments through a commemorative street name; and

10 WHEREAS, Elsie Tonelli, in her capacity as a local businesswoman, has significantly
11 contributed to the economic growth and development of the Excelsior District, pioneering
12 innovative strategies, and creating job opportunities for residents; and

13 WHEREAS, Elsie Tonelli consistently demonstrated a deep dedication to her
14 community, investing countless hours in volunteering, social services, and the betterment of
15 this locale through 73 years of operations at Central Drug Store; and

16 WHEREAS, Elsie Tonelli passed away on January 17, 2023, at the age of 96 and was,
17 at the time of her death, survived by six children, 18 grandchildren and 23 great-
18 grandchildren, who leave behind a legacy for decades to come; and

19 WHEREAS, San Francisco has a policy of naming at least 30% of public places after
20 women, and a June 22, 2023, report from the Department of the Status of Women shows that
21 only 7% of streets out of 600 are named after women; and

22 WHEREAS, This commemorative street name would further the goals of Ordinance
23 243-18; now, therefore, be it

1 RESOLVED, That to celebrate the legacy and contributions of Elsie Tonelli, there shall
2 be a commemorative naming of Mission Street between Santa Rosa Avenue and Excelsior
3 Avenue; and, be it

4 FURTHER RESOLVED, That the Department of Public Works is directed to add the
5 honorary street name to its official list of Commemorative Street Names in accordance with
6 Public Works Code, Section 789 et seq.




