10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Administrative Code is hereby amended by amending
12 Section 41D.1 to read as follows:

13 Sec. 41D.1. **TITLE**

14 This Chapter shall be known as the Residential Hotel Visitor Policy Ordinance. For
15 purposes of this Chapter, "Residential Hotel" shall have the same meaning as that set forth in
16 Administrative Code Section 41.4(p), except that housing sites operated by non-profit
17 organizations for the purpose of providing housing and supportive services to victims and
18 survivors of domestic violence, as confirmed by the Department on the Status of Women or its
19 successor(s), shall be exempt from the requirements of this Chapter.




