4 **Resolution retroactively approving Modification No. 3, the Close-out Modification, of**
5 **Professional Services Agreement for Contract No. 5600AE – North & South Int’l Parking**
6 **Garages, Concourse H/Airport BART Station and Rental Car Facility with ED2 Int’l/MBT**
7 **Architecture Joint Venture Architects in the amount of \$1,236,926, for a new total**

10 WHEREAS, By Resolution No. 95-0198, the Airport Commission awarded a
11 Professional Services Contract (Contract 5600AE) to ED2 Int’l/MBT Architecture Joint
12 Venture Architects, to provide complete architectural and engineering design services for the
13 North and South International Parking Garages (formerly Rental Car Garage/Ground
14 Transportation Center); and

15 WHEREAS, By various resolutions, the Airport Commission approved modifications to
16 the Professional Services Contract for a total current contract value of \$22,232,700 to provide
17 continuing and additional architectural and engineering design services for North & South
18 International Parking Structures, Concourse H/Airport BART Station and the Rental Car
19 Facility on Lot D; and,

20 WHEREAS, On January 30, 2003, the Airport Commission approved Modification No.
21 3 to the Professional Services Contract with ED2 Int’l/MBT Architecture, in the amount of
22 \$1,236,926 for a new total contract amount of \$23,469,626. A copy is on file with the Clerk of
23 the Board of Supervisors in File No. 030404, which is hereby declared to be a part of this
24 resolution as if set forth fully herein; and,

1 WHEREAS, In accordance with City Attorney Opinion No. 2002-03/Application of
2 Charter Section 9.118(b), whereby all contracts in excess of \$10 million or that have a term of
3 10 years or more, except for construction contracts, are subject to approval by the Board of
4 Supervisors, now, therefore, be it

5 RESOLVED, That this Board of Supervisors hereby retroactively approves Modification
6 No. 3 to the Professional Services Contract with ED2 Int'l/MBT Architecture in the amount of
7 \$1,236,926 for a new total contract amount of \$23,469,626.
