9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by amending Section
11 83.18 to read as follows:

12 **SEC. 83.18 OPERATIVE DATE AND APPLICATION.** Phase I, as defined in
13 83.4(n) shall become operative 30 days after the date the ordinance adopting this Chapter
14 becomes effective, Phase II, as defined in Section 83.4(o) of this Chapter will become
15 operative 24 (twenty-four) months after adoption of a resolution by the FSHA that Phase I has
16 been implemented. This Chapter is intended to have prospective effect only, and shall not be
17 interpreted to impair any rights under any existing City Contract or Property Contract or
18 Permit. The provisions of this Chapter shall expire ~~five~~ six years after the effective date of this
19 ordinance.


