3 **Resolution enacting and rescinding parking regulations at various locations.**
4

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:
8

9 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

10 Market Street, north side, from 64 feet to 143 feet west of Castro Street (a 79-foot
11 zone);

12 Mason Street, west side, from Jefferson Street to 40 feet southerly (removes two
13 parking meter spaces to accommodate buses turning left onto Mason Street);
and,

14 Geneva Avenue, south side, from Carter Street to 100 feet westerly.

15 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

16 Minnesota Street side of 1415 Indiana Street, from 2 feet to 9 feet north of the
17 Minnesota Street driveway for 1415 Indiana Street (accommodating two
18 unmetered motorcycle parking spaces).

19 **RESIDENTIAL PERMIT PARKING AREA "H" (2-HOUR TIME LIMIT, 8 AM - 6 PM,
MONDAY THROUGH FRIDAY) - ESTABLISH**

20 Beachmont Drive, both sides, between Sloat Boulevard and Lagunitas Drive (unit
21 block).

22 **RESIDENTIAL PERMIT PARKING AREA "R" (2-HOUR TIME LIMIT, 9 AM - 6 PM,
MONDAY THROUGH SATURDAY FRIDAY) - ESTABLISH**

24 Grove Street, both sides, between Buchanan and Webster Streets (700 block).

25 **DIAGONAL (60-DEGREE ANGLE) PARKING - ESTABLISH**

1 Stanyan Street, east side, from Fulton Street to McAllister Street (legalizing existing
2 conditions)

3 Categorically exempt from Environmental
4 Review Class 1(c)(9) changes in the traffic and
5 parking regulations where such changes do not
6 establish a higher speed limit or result in more
7 than a negligible increase in the use of the
8 street.

RESIDENTIAL PERMIT PARKING AREA "H" (2-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH

Beachmont Drive, both sides, between Sloat Boulevard and Lagunitas Drive (unit block).

RESIDENTIAL PERMIT PARKING AREA "R" (2-HOUR TIME LIMIT, 9 AM - 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH

Grove Street, both sides, between Buchanan and Webster Streets (700 block).

DIAGONAL (60-DEGREE ANGLE) PARKING - ESTABLISH

Stanyan Street, east side, from Fulton Street to McAllister Street (legalizing existing conditions)


